STATEMENT BY THE ZICA CHIEF EXECUTIVE OFFICER & THE SECRETARY, MR. BONNA KASHINGA.

ON THE RELEASE OF THE DECEMBER 2018 ZICA EXAMINATION RESULTS

28th February 2019

1.0 INTRODUCTION

I am delighted to inform the nation that the Zambia Institute of Chartered Accountants on Thursday, 31st January 2019 released the December 2018 Examination Results for its four (4) programmes namely: CA Zambia, Diploma in Accountancy, Diploma in Taxation, and Diploma in Public Sector Financial Management.

The December 2018 Examination was the third sitting since the launch of CA Zambia, Diploma in Accountancy and Diploma in Public Sector Financial Management in 2017. The Examination was written from Monday, 10th December, 2018 to Friday, 14th December, 2018. I therefore, congratulate all members of staff at the Institute and our strategic partners in the Examination process for the hard work and timely release of these results.

2.0 PERFORMANCE

The overall pass rates in all the programmes, except for the Diploma in Accountancy, were very impressive. The Diploma in Taxation recorded 86 percent pass rate while the Diploma in Public Sector Financial Management recorded 75 percent pass rate. In comparison with the June 2018 examination, the pass rates for CA Zambia programme have continued the upward trajectory. Notable under this programme was the 66 percent pass rate recorded at the Knowledge level. This high pass rate at Knowledge level of CA Zambia is attributed to the high entry requirements which has been set at a Grade 12 School Certificate or its equivalent with **five (5) Meritorious Grades** or better including Mathematics and English.

In terms of performance by gender, female candidates performed better than the male candidates in all the programmes, except the Diploma in Accountancy. It is therefore gratifying to note that our female candidates are performing so well in our examinations.

The performance by study modes showed that in all the programmes, the candidates who were on full time study performed better than those who were either on part time study or self-study. Students are therefore encouraged to attend classes from our accredited tuition providers in order to enhance their chance of passing.

In terms of performance by number of attempts, all programmes had better pass rates of candidates on their 1st attempt than those attempting on more than one (1) attempt. The 1st time pass rates ranged from 35% to 84% across the four (4) programmes. This is a clear demonstration that our examinations are passable contrary to the perception held by some students.

3.0 GRADUATES

A total of two hundred and thirteen (213) students completed the examination component of the CA Zambia in comparison to ninety seven (97) students in June 2018. These students are proceeding to undertake their supervised practical training.

A total of one hundred and thirty three (133) students graduated from the Diploma in Accountancy in comparison to three hundred and forty nine (349) students in June 2018.

Four (4) students graduated from the Diploma in Public Sector Financial Management in comparison to four (4) students in June 2018.

The Diploma in Taxation had nine (9) students graduating in comparison to eight (8) in June 2018 whereas the Certificate in Taxation had fifteen (15) students graduating in comparison to twenty two (22) in June 2018.
