WE WOULD LIKE TO THANK THE MINISTRY OF FINANCE AND THE ZAMBIA REVENUE AUTHORITY FOR CONTINUOUSLY ENGAGING ZICA ON ISSUES OF NATIONAL INTEREST SUCH AS THE SALES TAX BILL 2019. THIS SHOWS HOW MUCH THE GOVERNMENT CONSIDERS ZICA AS A PARTNER ON THE ECONOMIC DEVELOPMENT AGENDA OF OUR COUNTRY.

ADDITIONALLY, ZICA IS IN ACTIVE BILATERAL DISCUSSIONS WITH THE SOUTH AFRICAN INSTITUTE CHARTERED ACCOUNTANTS OF (SAICA), THE INSTITUTE OF CHARTERED ACCOUNTANTS FOR ENGLAND & WALES (ICAEW), THE INSTITUTE OF CHARTERED ACCOUNTANTS OF ZIMBABWE (ICAZ), THE INSTITUTE OF CHARTERED ACCOUNTANTS OF INDIA (ICAI), AMONG OTHERS, FOR MUTUAL RECOGNITION OF THE CA QUALIFICATIONS OF EACH INSTITUTE AND FREE MOVEMENT OF PROFESSIONAL ACCOUNTANTS.

THE APEI IS AN INITIATIVE OF FIVE (5) SOUTHERN AFRICAN COUNTRIES NAMELY, MALAWI, MAURITIUS, MOZAMBIQUE, SEYCHELLES AND ZAMBIA WHO AGREED TO ACCELERATE THEIR ECONOMIC INTEGRATION BY HARNESSING FOREIGN INVESTMENT, CREATING ENHANCED EMPLOYMENT OPPORTUNITIES AND FOSTERING HIGHER ECONOMIC GROWTH THROUGH SHARPENING THEIR COMPETITIVE EDGE.
