### **POSITION: INVESTMENT ANALYST**

Support the development team during the investment process to include financial modelling, market analysis, cash flow analysis review, and due diligence activities for new acquisitions, among others.

Specifically, the Investment Analyst shall be accountable to the Director Finance, Investment and Administration for the following:-

- Building, maintaining and monitoring financial models in Excel utilizing property financial statements, budgets, leases, and expense information and marketing assumptions;
- Supporting the underwriting, analysing and executing of real estate investments;
- Preparing and compiling due diligence materials, budgets, financial models and schedules;
- Identifying strengths and weaknesses of proposed transactions;
- Producing project proposals and materials necessary for presentations related thereto;
- Helping coordinating the closing of transactions;
- Maintaining and updating due diligence checklists for transactions;
- Preparing budgets, financial models, market reports necessary for debt/equity proposals and investor reporting (and then produce such proposals and reports);
- Carrying out market research;

- Generally staying informed of current industry and market trends including attending industry conferences;
- Facilitating project inspections and tours;
- Creating, monitoring, tracking and interpreting project data including contracts, schedules, budgets and cash flows on an on-going basis;
- Being involved with the procurement proposal for investment properties; and
- Assisting in other special projects and assignments as may arise from time-to-time.
