Introduction

The purpose of this document is to detail the Pathways applications requirements for admission to CA Zambia membership of ZICA.

This route to membership is referred to as the *experience* route. Candidates must meet the eligibility requirements and pass and Examination of Experience, as detailed below. The examination details are the subject of a separate document.

Pathways membership requirements

You must be an eligible applicant

To be eligible to apply for Pathways entry route, applicants must meet all the following eligibility criteria, the applicant *must be*:

- 1. a Fellow member of the ZICA who became a member using either the ZICA professional qualification or a foreign professional accountancy qualification from recognized Professional Accountancy Organisations,
- 2. a member in good standing without a disciplinary record, and
- 3. compliant with the CPD requirements of the Institute i.e. applicant must have submitted his/her CPD returns in the last five years this must be confirmed by membership department.

Exemptions applicable

The CA Zambia qualification has two key components: examinations and practical training. Through the Pathways route, exemptions shall be granted to applicants on the two key components based on their professional qualifications as indicated in the table below:

Exemptions fees

100% of the applicable examination fees for that year shall be charged as exemption fees for all CA Zambia subjects. Those that will be required to write CA3.2 – Advanced Audit and Assurance will have to pay CA Zambia examination fee rate for the subject at the prevailing for that year.

Examination of Experience

Candidates for Pathways membership are required to pass the Pathways examination of experience. The examination requirements are the subject of a separate document **Pathways Examination**.

The Examination has four (4) windows for submission – (January to February, April to May, July to August, October to November) and is submitted online. Results are released in April for Jan–Feb submission, July for April-May submission, October for July-August submission, and January for October-November submission.

Skills required for Pathways applications

The skills requirements for Pathways membership recognise:

- The skills developed under the CA Zambia qualification to which a Pathways variant must pay attention to and, where relevant, recognise as being appropriate for Pathways membership, and
- Additional skills, based on experience, that Pathways candidates would reasonably expect to demonstrate as relevant criteria for Pathways membership of ZICA.

To this end, the following skills matrix recognises all the headings for skills expression that are identified for CA Zambia members qualified under the examination route.

Additionally, Pathways members would have had significant experience gained in their workplace, at senior levels, that would not ordinarily feature as part of the work experience gained for candidates under the examination route, largely because they would not have held the seniority that would be associated with a range of experiences. To this end, the skills matrix for Pathways applications extends the scope of relevant experience beyond that described in the CA Zambia that would be considered as part of a Pathways application.

The Pathways Skills Matrix (PSM) detailed in Appendix 1.

The key expression of the PSM is that it identifies:

- 1. Key competencies that detail the skills required, and
- 2. Key processes where competencies are expressed.

The detail of the key competencies required and the key processes are the subject of a companion document *3 Skills requirements for Pathways membership of CA Zambia*.

Application procedures

Requirements

You must meet the Pathways membership requirements, detailed in paragraph above.

Your application will consist of:

Part A

 A completed application form (see Appendix 2). Email form to <u>examinations@zica.co.zm</u> A review of your eligibility will then be undertaken and, if accepted, you will then be required to pay a fee and submit the remaining documents as described in Part B.

Part B

- 1. Payment of fees due
- 2. A completed Examination of Experience

Guidance

You are likely to be successful in your application if:

- 1. You are an eligible applicant,
- 2. You are concise, detailed and relevant in what you say in your examination. Detailed guidance to the examination is provided in the examination document,
- 3. You can evidence what you say and are credible in your achievements,
- 4. Your examination form is complete and you have paid the relevant fee, and
- 5. You are not barred from making a further attempt at the examination.
