### HOLDING OF JUNE 2020 EXAMINATION

Notice is hereby given that the Institute has been granted permission by the Ministry of Health through the Zambia National Public Health Institute, to hold the June 2020 Examinations under strict conditions in line with Statutory Instruments No 21 and 22 of 2020. These conditions are as follows:

1. Restricted number to not more than 50 people;
2. Physical distancing of not less than one meter;
3. Provision of hand washing and sanitation facilities, enforced hand hygiene;
4. Wearing of Masks throughout the examinations; and
5. The examination rooms must have adequate ventilation.

In order to comply with the above guidelines from the Ministry of Health, the Institute would like to urge all candidates to ensure that they adhere to the guideline of wearing facemasks during the examination sessions. **No candidate will be allowed in the Examination hall without wearing a facemask.**

### DATES FOR THE JUNE 2020 EXAMINATIONS

According to the Examinations Calendar for the year 2020, the June 2020 Examinations were scheduled to be conducted from 15<sup>th</sup> to 19<sup>th</sup> June 2020 in the twenty (20) examination centers across the country. However, due to the late grant of the permission to hold the examinations, the Institute has moved the dates forward in order to allow for the pre-examinations activities to be concluded.

As such the June 2020 Examinations would be held **from Monday, 22<sup>nd</sup> June 2020 to Friday, 26<sup>th</sup> June 2020.**
