1.0 CALL MEETING TO ORDER

The President called the meeting to order at 10:25 hours upon confirmation that the 10% quorum of paid members as at 31st December 2018 was met as per the requirement of the Constitution. The President declared the meeting to be duly constituted.

2.0 NATIONAL ANTHEM

The President led the members in the singing of the National Anthem.

3.0 OBSERVANCE OF A MINUTE OF SILENCE

The President called on members to observe a minute of silence in honour of members of the Institute who passed on since the last AGM.

4.0 OFFICIAL OPENING OF THE 34TH ANNUAL GENERAL MEETING

The 34th Annual General Meeting was officially opened by the Guest of honour, Hon. Margaret Mwanakatwe, MP, Minister of Finance after remarks by the ZICA Secretary and Chief Executive Mr. Bonna Kashinga and welcome remarks by the ZICA President Mr. Jason Kazilimani Jr. During her official opening, the Minister of Finance made the following key pronouncements:

4.1 Development of Shungu Namutitima International Convention Centre (SNICC) in Livingstone

The Minister reaffirmed the commitment of His Excellency the President of the Republic of Zambia Dr. Edgar Chagwa Lungu, on providing the Institute with a Sovereign Guarantee to enable the Institute secure affordable finance in the development of SNICC. SNICC would comprise a 5000 seater International Convention Centre, a five star hotel, a three star hotel, 10 Presidential villas and an 18 Hole golf course.

4.2 Registration of Accountants in the Civil Service

The Minister expressed Government's commitment in ensuring that Accountants in the Civil Service adhered to the provisions of the Accountants Act of 2008 by being in good standing with the Institute. The Minister requested the Deputy Secretary to the Cabinet Mr. Christopher Mvunga to expedite the process of ensuring that annual subscription fees for Accountants in Government are paid to ZICA.

4.3 Sales Tax Bill 2019

The Minister indicated that the Sales Tax Bill was presented to Parliament for the first reading and the second reading including the finalization of the bill would be concluded during the June 2019 session. The Minister further indicated that due to the significance of the reform, she was undertaking nation-wide consultations with key stakeholders. Accountants were urged to take keen interest and provide input into the final draft bill which would be enacted into Law. The Institute was commended for holding sensitization workshops on the Sales Tax Bill 2019.

4.4 Public Finance Management Act number 1 of 2018

The Minister reminded Accountants that the Public Finance Management Act which provides for an institutional and regulatory framework for the management of public finances was enacted in 2018. The Minister appealed to all Accountants both in the public and private sectors to refrain from misappropriation of funds.

4.5 International Public Sector Accounting Standards (IPSAS)

The Minister indicated that the Government would adopt IPSAS as the financial reporting framework for the public sector by 2024. The Minister further indicated willingness to partner with the Institute on the provision of technical assistance towards capacity building for the public sector on the IPSAS implementation.

After a question and answer session at which the Minister gave clarifications to the issues raised, the 34th AGM convened as follows:

5.0 ADOPTION OF THE AGENDA

The President called on the Secretary to read the notice for the meeting. The Secretary and Chief Executive read out the Notice of the Annual General Meeting. The agenda was adopted after being proposed by Mr. Tom Thewo and seconded by Mr. Mboo Mumba.

6.0 RECEIVE AND ADOPT THE MINUTES OF THE 33RD AGM HELD AT AVANI VICTORIA FALLS RESORT, LIVINGSTONE, ON 28TH APRIL 2018

The minutes of the 33rd Annual General Meeting were laid before the members for consideration and adoption.

Corrections

There were no corrections to minutes of the 33rd Annual General Meeting.

There being no corrections to be made, the minutes of the 33rd Annual General Meeting held on 28th April 2018 were adopted as a correct record of the proceedings thereof after being proposed by Mr. John Nkonjela and seconded by Mr. Tinashe Jerahuni.

7.0 RECEIVE AND CONSIDER THE MATTERS ARISING REPORT FROM THE MINUTES OF THE 33RD AGM HELD AT AVANI VICTORIA FALLS RESORT, LIVINGSTONE, ON 28TH APRIL 2018

7.1 Chief Justice's Rules

It was reported that the Chief Justice's Rules had not yet been finalised and were still at Ministry of Justice.

7.2 Resolution to Amend Section 19(2) of the Accountants Act

The members were informed that the draft bill had been prepared and was being reviewed by the Ministry of Justice.

7.3 Statutory Instrument on Fees

It was reported that the Ministry of Finance signed the Statutory Instrument on fees during the year. However, due to concerns raised by stakeholders, the SI was revoked on 5th February 2019. After the revocation of the SI 34, and under the instruction of the Attorney General, a task force comprising Ministry of Finance, Ministry of Justice and ZICA was constituted to redraft the Statutory Instrument. The new draft Statutory Instrument was finalised and submitted to the Ministry of Finance through the Accountant General's Office for onward submission to the Ministry of Justice.

7.4 Raising Finances for ZICA Properties Ltd

The meeting was informed that the members had continued making contributions to the fund and that 666 members had contributed to the fund by the reporting date.

The members were further informed that a Contract with Time Projects Property Zambia Limited for the development of a mixed-use facility at the Accountants Park was signed after obtaining the necessary approvals from the Management Procurement Committee and the Board of ZICA Properties Limited. Time Projects would raise the component of the debt finance.

7.5 Payment of Subscriptions by Government

The members were informed that the Institute had continued to engage Government through the Office of the Accountant General who during the first quarter for 2019 provided a list of about 2 700 accounting staff under his portfolio. Of these, 2 137 accounting staff were not registered with the Institute and the Institute advised the Office of the Accountant General of the subscriptions due from the accounting staff. A settlement decision of the subscriptions due was being awaited from the Accountant General.

7.6 Restriction on outsourcing accounting services to centres of excellence

The members were informed that there was no law or regulation that prohibits the outsourcing of accounting services to centres of excellence and as a result, the Institute could not enforce the proposal. The members were informed that under the current laws, it was a business decision of each company to determine how accounting services were procured whether by having in-house expertise or using group centres of excellence. The Directors of any company incorporated in Zambia are responsible for the financial affairs of the company they represented and take full ownership of financial statements generated including those produced from centres of excellence.

7.7 10% of the Subscription fee to be converted to Benevolent Fund

The members were informed that apart from the voluntary contributions from the members, 10% of the income from the Annual Ball tickets was allocated to the Benevolent Fund annually. Council was of the view that unless the proposal was a mark-up to the subscription, it would have a negative impact on the budget of the Institute and therefore did not approve the proposal. Further, the Institute secured a life plan for each member from Prudential Life Assurance which provides a cash pay-out and funeral assistance to the family of a deceased member.

8.0 RECEIVE AND ADOPT THE PRESIDENT'S, SECRETARY AND CHIEF EXCEUTIVE 'S ANNUAL REPORTS FOR 2018

The President presented the Annual report for the year ended 31st December 2018 which comprised the President's Report, Secretary and Chief Executive's report, Financial and Operational Review, Sustainability Report and Corporate Governance Statement.

Matters arising from the 2018 Annual Report

8.1 Corporate Social Responsibility Policy

In response to a member who wanted to know if the Institute had a Corporate Social Responsibility policy, members were informed that the Institute had Corporate Social Responsibility guidelines but a Policy would have to be developed.

8.2 Timeframe when investors into the ZICA Property Fund would start receiving investment returns

On the timeframe when investors into the ZICA Property Fund would start receiving investment returns, the members were informed that the investors would start receiving returns after seven (7) years. The members were further informed that an update on the ZICA Property Fund from the Fund Manager was an agenda item of the meeting and hence the Manager would provide further clarity on the matter.

8.3 Voluntary or Mandatory contribution to the ZICA Property Fund

On whether the contribution to the ZICA Property Fund was voluntary or mandatory, it was stated that the contribution was mandatory. The members were further informed that the Securities and Exchange Commission (SEC) clarified that there were no provisions of the Act that prohibited the mandatory investment into a collective investment scheme by the investor. The Institute was therefore on firm ground regarding the ZICA Property Fund.

8.4 Environment Impact Assessment Report for SNICC

On whether there was an Environmental Impact Assessment (EIA) Report on the SNICC Project, the members were informed that the report was yet to be issued. However, the public hearing was held and the project was well received by the community and key stakeholders.

8.5 Registration of Accounting Staff under Accountant General's Office

On what the Institute was doing in order to register the 2,137 accounting staff under the Office of the Accountant General who were not registered with the Institute, the Institute informed the members that the Accountant General had been given a directive to ensure that all accountants under his office were registered with the Institute. The Accountant General further informed the members that his office was in discussion with Cabinet Office, on the options available to enable Government pay the subscription to the Institute.

8.6 Top up Degree with ZCAS

On whether the Top up degree was open to all students or its only for CA Zambia students, the members were informed that the Top up degree would be open to only CA Zambia and former ZICA programme students who had attained the Application and Licentiate levels respectively.

8.7 Practical Training for CA Zambia

In response to a member who wanted to know what the Institute had put in place for practical training and what it takes to be a mentor, the members were informed that a trainee needed to undergo practical training under an employer who had been approved by the Institute. Members were further informed that for such an employer to be approved, they should among other requirements have professionally qualified accountants (Associate and Fellow members) who would be mentors to the trainee. Further the members were informed that once the employer had been approved, the mentors needed to undergo a practical training orientation training before practical training could commence.

8.8 Sensitization of employers on the levels of the ZICA Qualifications

On a comment from the member who urged the Institute to continue sensitizing employers on the levels of the qualifications that the Institute was offering, the Institute noted the comment and informed members that the Institute had a marketing program in place and would continue sensitizing the employers on the competencies of ZICA graduates.

8.9 Change of Qualification names

On what guarantee the Institute had that the name of CA Zambia would not be changed like the change from NATech to ZICA and from ZICA to CA Zambia, members were informed that the change of the names were inevitable but there would be no change in names in the shortest possible time.

It was resolved that: "The Annual reports for the year ended 31st December 2018 be adopted". The Annual Reports were adopted after being proposed by Mr. Wesley M. Beene and seconded by Mr. Tom Thewo.

9.0 RECEIVE AND ADOPT THE AUDITED FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 $^{\rm st}$ DECEMBER 2018

The Auditors of the Institute – BDO Zambia presented their audit opinion. Following the presentation of the audit opinion, the Chairperson for the Finance and Administration Committee, gave highlights of the Financial Statements and laid before the members the Audited Financial Statements of the Institute for the year ended 31st December 2018.

It was resolved that: "The Audited financial statements for the year ended 31st December 2018 be hereby adopted".

The Audited financial statements for the year ended 31st December 2018 were adopted after being proposed by Mr. Joseph Ngulube and seconded by Mr. Eric Masumbu.

10.0 RECEIVE AND ADOPT RECOMMENDATION FOR APPOINTMENT OF AUDITORS FOR 2019

Members were informed that the Auditors, BDO Zambia had expressed willingness to be reappointed as external auditors for the Institute for the 2019 financial year and were being recommended for reappointment.

It was resolved: "That Messrs. BDO be appointed as external auditors for the Institute for the financial year 2019 and that Council be authorized to determine their remuneration." The recommendation was adopted after being proposed by Major Humphrey Mutambo (Rtd) and seconded by Mr. Michael Phiri.

11.0 RECEIVE AND ADOPT THE DISCIPLINARY COMMITTEE ANNUAL REPORT FOR 2018

A member of the Disciplinary Committee, Mr. Mukelebai Wambulawae presented the Committee report to the members.

It was resolved: "That the Disciplinary Committee Annual report for the year ended 31st December 2018 be hereby adopted." The Disciplinary Committee report was adopted after being proposed by Mr. Michael Phiri and seconded by Major Humphrey Mutambo (Rtd).

12.0 RECEIVE AND ADOPT THE STANDARDS AND REGULATORY BOARD ANNUAL REPORT FOR 2017

A member of the Standards and Regulatory Board, Mr. Raphael Kasonde presented the Standards and Regulatory Board report for the year ended 31st December 2018 to the members.

It was resolved: "That the Standards and Regulatory Board report for the year ended 31st December 2018 be hereby adopted." The report was adopted after being proposed by Mr. Tinashe Jerahuni and seconded by Ms. Bridgette Muyenga.

13.0 RECEIVE AND ADOPT THE BENEVOLENT FUND ANNUAL REPORT FOR 2018

The Vice Chairperson of the Benevolent Fund Board of Trustees, Mr. Fred Namakando presented

the report for the year ended 31st December 2018 to the members.

It was resolved: "That the Benevolent Fund Board of Trustees report for the year ended 31st December 2018 be hereby adopted." The report was adopted after being proposed by Mr. Kelvin Nali and seconded by Mr. Humphrey Muyamba.

14.0 ANY OTHER BUSINESS

14.1 The Silo between Benevolent Fund and Prudential Life Assurance

It was suggested that there was need to break the silo between Benevolent Fund and Prudential Life Assurance. The Institute clarified that the two (2) schemes were distinct but they complemented each other.

14.2 Increase number of inspections

It was suggested that the Institute should increase the number of inspections in order to curtail the number of people holding out as accountants. The suggestion was noted and Council promised to increase the number of inspections.

14.3 Performance Report of the ZICA 2014-2018 Strategic Plan

It was suggested that the Institute should have presented a report on the performance of the strategic plan 2014-2018 to the members. The suggestion was accepted and Council promised that the next report would include a performance review of the ZICA Strategic plan.

15.0 UPDATE ON ZICA PROPERTY FUND FROM THE FUND MANAGER

The Fund Manager, Equity Capital Resources through Mr. Nathan De Assis presented the update on the ZICA Property Fund.

15.1 Matters arising from the update on the ZICA Property Fund

15.2 Targeted Investment Amount for ZICA

On whether the funds being contributed were for the construction of the mixed-use facility at the Accountants Park and Livingstone (SNICC), it was clarified that all the funds were for the Accountants Park Project.

15.3 Over valuation of land

Concern was expressed on the possibility of an over valuation of the land. It was clarified that the valuation, was conducted by a registered professional valuer with recent experience in the fair value measurement of properties in the location.

16.0 ELECTION OF ONE (1) COUNCIL MEMBER

The President invited the Electoral Committee to conduct the polls.

The Electoral Committee Chairperson Major Humphrey Mutambo (Rtd) announced the vacant position of one (1) Council member from Commerce and Industry.

The Chairperson then invited the validly nominated candidates for the position of Council member to address the Annual General Meeting. Following the electronic voting that was conducted, the election results were verified by an independent auditor, Mr. Andrew Chibuye. The returning officer Ms. Brigitte Muyenga announced the elected member and declared her as a duly elected Council member henceforth as follows:

6.0 PROPOSED RESOLUTIONS

6.1 Resolution to Appoint External Auditors

BDO, the current external auditors of the Institute expressed willingness to be reappointed as external auditors for the 2020 financial year.

Resolution

It is hereby proposed and recommended by Council that Messrs BDO be appointed as external auditors for the Institute for the financial year 2020 and that Council be authorised to determine their remuneration.

6.2 Resolution to amend the ZICA Constitution

Council has noted some key defects in the ZICA Constitution and the ZICA Electoral Rules of 2010 which need to be remedied through a holistic review of the ZICA Constitution and the ZICA Electoral Rules. This was further confirmed by a group of Members who collected signatures to ensure that the ZICA Constitution was amended. Some of the current defects of the ZICA Constitution and Electoral Rules include the following:

- The lack of provisions for virtual holding of the key member meetings of the Institute such as the Annual General Meeting and Special General Meetings including voting virtually;
- ii. Lack of provisions on legal persona of the Institute;
- iii. Lack of gender mainstreaming of Council;
- iv. Lack of provisions which provide for ZICA Chapters;
- v. Lack of provisions which provide for honorary membership categories;
- vi. Ambiguity and misdirection in some sections by the use of the term "practice" when making reference to a chartered accountant who is employed under a contract of service;
- vii. Failure to separate Council from the duty of appointing the Electoral Committee, a process in which Council has a perceived conflict of interest;
- viii. Lack of the eligibility criteria for the Electoral Committee and
- ix. Harmonization of the ZICA Constitution with the 2019 Accountants Bill which is expected to be enacted into law either in the second half of 2020 or in early 2021. (See Appendix II).

Resolution

It is hereby resolved that the amendment of the ZICA Constitution and the Electoral Rules and Regulations be hereby adopted and approved.

6.3 Resolution to allow graduates, licentiates and Technicians to offer restricted/limited accounting services

The Accountants Act and the Constitution of Zambia Institute of Chartered Accountants only allow Fellows and Associates to engage in public practice. Section 19 of the Accountants Act refers to a Chartered Accountant being eligible to apply for a practicing certificate or non-audit certificate. The Accountants Act defines a Chartered Accountant as being a person holding an associateship or fellowship grade of membership of the Institute and registered as an accountant under section fifteen. Similarly, the Constitution under section 10 and 11 only allows Chartered Accountants (Fellows and Associates) to apply for a practicing certificate or a non-audit practicing certificate.

A proposal is therefore being brought before the Annual General Meeting to amend section 11 of the Constitution to allow Graduates, Licentiates and Technicians with 2 years' work experience to be allowed to offer limited services such as file tax returns, provide accounting services to a client, prepare financial statements as well as prepare financial and accounting reports for entities whose turnover does not exceed K5 million for Graduates, K4 million for Licentiates and K3 million for Technicians.

The proposal is to amend clause 11 so that it reads "Upon a written application to the Institute by an eligible member for a Non-audit Practicing Certificate and on payment of a prescribed fee, the Council may issue a non-audit practicing certificate in accordance with requirements set out in Section 19 of the Act."

The changes to the Accountants Act to allow these members to practice will be incorporated in the current process of adopting the Accountants Bill if the Annual General Meeting approves the motion to amend the constitution to allow Graduates, Licentiates and Technicians to engage in limited practice. (Appendix I)

Resolution

It is proposed that the meeting adopts the recommendation to introduce other categories of practitioners and make a resolution to amend the constitution and replace section 11 of the constitution with the following "Upon a written application to the Institute by an eligible member for a Non-audit Practicing Certificate and on payment of a prescribed fee, the Council may issue a non-audit practicing certificate in accordance with requirements set out in Section 19 of the Act."

6.4 Resolution to adopt the recommendation on the ZICA Property Fund

Background

The Institute set up the ZICA Property Fund in its quest to raise financing for the development project at the Accountants Park . This is a mandatory fund where all ZICA members are supposed to contribute US\$2,500 each over a five year period. This came into being through a resolution by members at the 32nd Annual General Meeting (AGM) held on 29th April 2017. The Fund Manager, Equity Capital Resources (ECR), manages the fund. It was envisaged to raise between US\$10 million –US\$15million from members. This was under the premise that approximately 4000-6000 would participate in the investment in unit trusts.

The offer price was US\$10 per unit with a minimum investment of 5 units for individuals and 100 units for companies. The Institute holds up to 51% of the fund while members and other investors hold 49%. The cash to be raised from this offer would be applied towards the construction of ZICA office park on plot 2374/A Thabo Mbeki road.

The fund

The uptake of the fund was low when the fund was operationalised in 2018 with only 324 members contributing. In 2019, the Institute billed members K500 together with their subscriptions. This period witnessed an exponential growth in the members who contributed to the fund. A total of 4012 members contributed to the fund during 2019. In 2020, members were billed US\$500 separate from their subscriptions and the contributions have reduced drastically with only 34 members contributing so far. The total collections as at 30 April 2020 stood at US\$252,963. The amount significantly falls short of the funds required to commence construction. Council considered the following options when reviewing the uptake of the fund;

Option 1: Continuing with the investment in unit trusts

The set up of a collective investment scheme as regulated by the Securities and Exchange Commission of Zambia, allows the members to make an investment decision though mandatory, but serving the interest of the professional in the long term. The concept of continuing with the Unit Trust will provide members an opportunity to raise the set aside sum of \$ 2,500 over a period of time as an investment amount.

The members need to resolve as they have done to continue to make payments towards the respective US \$ 2,500 as a way to actualise the project.

The commitment by members will serve as an attraction for possible external financing and developers who will have an exit interest in the long term through the funds raised via the Unit Trust

Option 2: Introducing a levy

With regards to a levy, a Statutory Instrument (SI) will have to be secured through the Ministry of Finance. A levy does not provide the same benefits as an investment opportunity in the scheme. However, the Levy will attract a one off coupon payment to members to be decided by the council on completion of construction and occupancy of the facility. The levy will be non refundable.

When it becomes an SI then the members will be required to make the payment as part of the annual subscription to the profession. The issue of a levy is being considered arising from the low levels of participation by the members. When approved, the Institute proposes to request the Minister of Finance to issue a statutory Instrument in order to operationalise the levy.

The apathy in the collection of funds for the unit trusts from members has significantly contributed to the delay in the commencement of the Accountants park project. The Institute is supposed to contribute 50 % of the construction cost in the Special Purpose Vehicle (SPV) which will be cowned with Time Projects.

Recommendation

In view of the above, the Council is proposing to introduce a levy, which should be collected from each member. The investment amount of US\$ 2,500 currently being collected, should be levied on all members over a five year period. Contributions so far received from members should either be paid back to the members with interest earned net of fund management expenses or converted into a levy. The ZICA Property Fund should be closed once refunds are processed.

Resolution

It is hereby resolved that the recommendation to introduce a levy of US\$2,500 on all registered members over a five year period is hereby adopted and approved.

7.0 REPORT OF INDEPENDENT COMMITTEES

7.1 DISCIPLINARY COMMITTEE

The main purpose of the Disciplinary Committee is to hear disciplinary cases, determine and provide a reasoned judgement in such matters.

7.1.1. MANDATE OF THE COMMITTEE

The establishment and mandate of the Disciplinary Committee is provided for in Part VII of the Accountants Act of 2008. The Disciplinary Committee may receive complaints against members who have violated Section 72 of the Act and/or the code of conduct of members.

7.1.2. REPORTABLE ACTIVITIES

During the year under review, there were four (4) meetings held. There were two case hearings on professional misconduct and three cases on examination malpractice.

1. Professional misconduct

- (a) A complaint was received against a member for professional misconduct of paying himself a higher salary which he was not entitled. The Respondent admitted the charge and indicated that all the monies in question were paid back to his former employers. The Disciplinary Committee found the Member guilty of professional misconduct as defined in Section 72 (a) (b) (c) (d) (e) and (f) of the Accountants Act and ordered his membership to be suspended for one year.
- (b) A complaint was received against a member for professional misconduct of misappropriation of funds for his employers. The Respondent admitted the charge and indicated that 80% of the monies involved was paid back to the organisation. The Disciplinary Committee found the Member guilty of professional misconduct as defined in Section 72 a) (b) (c) (d) (e) and (f) of the Accountants Act. The DC ordered a one year suspension of his Membership and ordered the Member to pay back the remaining amount to his former employers.

2. Examination Malpractice

- (a) The complaint was an examination malpractice by a student who was using a cell phone during the examination. The Respondent admitted the charge. The DC found the Respondent guilty of professional misconduct as defined in Section 72 (c) of the Accountants Act No. 13 of 2008. The DC ordered a two year suspension period for his registration as a student.
- (b) The complaint was an examination malpractice by two students. One aided the other to copy from him during the examinations. The students admitted the charge. The DC found the students guilty of professional misconduct as defined in Section as defined in Section 72 (c) of the Accountants Act. The DC ordered a three year suspension period for the registration as students.

7.2 BENEVOLENT FUND BOARD ANNUAL REPORT FOR 2019

Objectives and Operations of the Fund

The principle objective of the Fund is to raise and maintain funds for the purpose of assisting persons in need that are or have been members of the Institute and their spouses or dependents. The Fund also targets to provide critical medical care to members within Zambia on a case by case basis. However, due to constraints in financial resources the assistance is restricted to payment of school fees for children of deceased members.

The fund depends on volunteers for all its administrative work including honorary audit services provided by HLB Reliance.

The major sources of income for the Fund include contributions by members, donations and interest on investments. The income is invested in interest bearing financial instruments. The Fund assists beneficiaries by awarding educational grants to children of deceased members.

Business Transacted during the Year

The Benevolent Fund Board met three times during the year under review to review the financial performance of the fund, review strategy and approve financial statements.

Financial Assistance

During the year the Board continued supporting 5 children of late members by paying for their school fees. Of these children, four (4) are at secondary school and one (1) is at University.

Financial highlights

Income

Based on the audited financial statements, the Fund recorded a total income of K45, 500 compared to the K47, 900 in the previous year. The sources of income were as follows:

As can be seen from the table above, contributions from members have continued to decline threatening our ability to continue supporting persons in need.

Expenditure

The Board spent a total of K31, 463 compared to K72, 366 in the previous year. Of the total expenditure, K28, 315 was spent on requests for school fees for children of late accountants against K67, 831 in the previous year.

Projected Expenditure

In the 2020 financial year, projected expenditure is around K130, 000 arising from new cases being recorded.

Investments and Bank balance

As at 31st December 2019, the bank balance was K88, 488 (2018, K9,444) and short term investments stood at K 119, 665 as compared to K107, 815 for the previous year.

At this rate, the Fund may not meet financial needs of our beneficiaries beyond this year. The available resources can only pay for school fees for one year. It is in this regard that we wish to make an earnest appeal for charitable contributions from members for us to continue on our path to serve families in need. We must attest that the Fund has given hope to many families of our deceased members who have been at the point of destitution.

On behalf of the Benevolent Fund Board I want to thank all members who made a contribution in any way to the activities of the Fund during the year 2019. The Fund appreciates any assistance members can give to ensure that the Fund continues to provide support to all beneficiaries who are in need. The effectiveness of the Fund depends on the collective contributions of members. As indicated in the financial highlights, membership contributions have continued to decline whereas requests for financial assistance are on the rise. This trend will adversely affect the Fund's operations.

1.0 INTRODUCTION

According to section 19(1) and (2) of the Accountants Act 2008 only Chartered Accountants with 7 years post qualifying experience are allowed to practice either as an audit practitioner or a non-audit practitioner. Section 19(1) and (2) of the Accountants Act 2008 reads "(1) A chartered accountant shall apply for a practicing certificate or a non-audit practicing certificate in the prescribed manner and form upon payment of the prescribed fee. (2) The Institute shall, where an applicant— (a) has been certified by a professional body or a body recognised under section thirteen to have complied with the education and training requirements; and (h) has passed the competence practice examination set by the Institute and has obtained competence to practice and a period of more than seven years has elapsed between the date of complying with the education and training requirements and the date of the application; issue the applicant with a practicing certificate or a non-audit practicing certificate in the prescribed form."

A Chartered Accountant is defined by the Accountants Act 2008 as "a Chartered Accountant means a person holding an associateship or fellowship grade of membership of the Institute and registered as an accountant under section fifteen"

Furthermore the Constitution only allows Fellows and Associates to offer non-audit practice. Section 11 of the constitution states "Upon a written application to the Institute by a Chartered Accountant for a Non-audit Practicing Certificate and on payment of a prescribed fee, the Council may issue a non-audit practicing certificate in accordance with requirements set out in Section 19 of the Act." As indicated above Chartered Accountant is defined in the Accountants Act of 2008 as follows: "Chartered Accountant means a person holding an associate or fellowship grade of membership of the Institute".

This means that only Fellows and Associates are allowed to practice according to the Accountants Act and the and the Constitution. Members in the categories of Graduates, Licentiates and Technicians are not allowed to practice.

The Standards and Regulatory Board is proposing that members in the Graduate, Licentiate and Technician category be allowed to provide limited services in line with their experience.

2.0 BACKGROUND

The reason behind the proposal to allow Graduates, Licentiates and Technicians to offer limited services is to ensure that those who fall in this category and who may be offering some form of accounting services without be registered with Zambia Institute of Chartered Accountants (ZICA) can be formally regulated by ZICA. There are a lot of people who are offering accounting services in the closet without being regulated by ZICA and many of them should be in this category of membership as they do not meet the 7 years' experience requirements in the Accountants Act and they are not Fellows or Associates. If ZICA was to allow these members to obtain practicing licenses, majority of them would come forward to be regulated by ZICA and this would greatly reduce the risk that poor quality work would be provided to clients. A search done at Patents and Companies Registration Agency for business names, limited companies and foreign companies registered with nature of business being offering accounting services, bookkeeping or financial advisory services revealed that there are 746 Business names, 595 Limited companies and 4 foreign companies listed with this nature of business. On the other hand, ZICA only has 101 audit firms and 32 non-audit firms registered meaning that about 1,212 entities are offering accounting services without being registered with ZICA.

Furthermore, expanding the practicing certificates to Graduates, Licentiates and Technicians will promote entrepreneurship among these members. This is particularly important with the present economic challenges where the unemployment level is high. According to a Zambia Statistics Agency

Zambia Labour Force Survey Report as at 2018, the unemployment rate was 11.4%. When we include the potential labour force, who are people available to work but are not actively looking for a job, the rate rises to 41.2%. These figures give an indication of the possible level of unemployment among accountants as well. Allowing Graduates, Licentiates and Technicians to provide limited services will therefore allow those members with the necessary experience who may be unemployed to be able to engage in gainful work as well as to be able to provide employment to others.

This paper therefore proposes the issuance of limited non-audit practicing certificates to Technicians, Licentiates and Graduates to allow them to offer restricted or limited services to members of the public.

3.0 MODELS ADOPTED BY OTHER COUNTRIES

A few countries where explored to understand what models they have adopted. These models are discussed below:

3.1 Lesotho

Lesotho Institute of Chartered Accountants (LIA) has three membership categories, being Chartered Accountant, CA (L), General Accountant, GA (L) and Technician Accountant, TA (L). All categories of membership are allowed to set up in practice once the meet the years of experience requirement. Chartered Accountants need to meet 3 years' experience requirements. General Accountants need to meet 2 years' experience requirements. Technician Accountants need to meet 1 year experience' requirements.

Only Chartered Accountants are allowed to offer Audit services. General Accountants have to have semi-professional qualifications while Technicians must have a Technician qualification. Technicians are allowed to offer Tax services computation and filling of returns, as well as prepare financial statements for companies with a turnover of upto ZAR500,000 (Kwacha 491,300.00). General Accountants are allowed to offer Tax computation services computation and filling of returns, as well as prepare financial statements for companies with a turnover of upto ZAR1000,000 (Kwacha 982,600.00).

3.2 Botswana

The Botswana Institute of Chartered Accountants allows Technicians who have Association of Accounting Technician level 4 qualification or a Bachelor's Degree in Accounting to obtain a non-audit practice certificate. To qualify for this certificate the applicants must meet a 2 year work experience requirement. Technician members who are holders of non-audit practice certificates are allowed to offer bookkeeping, preparation of financial statements, manage payments on behalf of clients, prepare tax returns as well as offer company secretary services.

3.3 South Africa

The South African Institute of Chartered Accountants (SAICA) offers an Accounting Technician qualification. Holders of this qualification who have 1 year experience are allowed to offer limited services to clients which include bookkeeping, offering tax services, and being a commissioner of oaths as well as preparation of financial statements.

4.0 PROPOSED COURSE OF ACTION

4.1 Framework being proposed

A new framework will be implemented which will involve splitting the non – audit practicing certificates into Full Non-Audit practicing certificate (to cater for existing certificate holders in the fellow or associate category), Technician Non-Audit Practicing Certificate, Licentiate Non-Audit Practicing Certificate and Graduate Non-Audit Practicing Certificate. The Practicing Certificate which caters for Audit Practicing Certificates will remain unchanged. The new categories of Non-Audit Practice Certificates will be as below:

i. Technician Non-Audit Practicing Certificate – This will allow practitioners to compute and file tax returns, provide external accounting services, prepare financial statements as well as prepare financial and accounting reports for entities whose turnover does not exceed K3,000,000 per annum, which has less than 50 employees and has investments less land and buildings of not more than K1,875,000. This category of practice certificate will also be restricted from providing services to public interests entities such as entities listed on the securities exchange, entities licensed and supervised by the Bank of Zambia, Pensions and Insurance Authority and Securities and Exchange Commission.

Technicians who have only completed the Diploma in Taxation will only be allowed to compute and file tax returns and prepare payrolls for entities whose turnover does not exceed K3,000,000 per annum, which has less than 50 employees and has investments less land and buildings of not more than K1,875,000. They will also be restricted from providing services to public interests entities such as entities licensed and supervised by the Bank of Zambia, Pensions and Insurance Agency and Securities and Exchange Commission.

These members will also be prohibited from working on complex assignments such as among other things:

- a. Insolvency practice;
- b. Transfer pricing assignments;
- c. Cross border work: and
- d. Double taxation treaty work
- ii. Licentiate Non-Audit Practicing Certificate This will allow practitioners to compute and file tax returns, provide accounting services to a client, prepare financial statements as well as prepare financial and accounting reports for entities whose turnover does not exceed K4,000,000 per annum, which has less than 80 employees and has investments less land and buildings in of not more than K2,500,000. This category of practice certificate will also be restricted from providing services to public interests entities such as entities listed on the securities exchange, entities licensed and supervised by the Bank of Zambia, Pensions and Insurance Authority and Securities and Exchange Commission.

These members will also be prohibited from working on complex assignments such as among other things:

- a. Insolvency practice;
- b. Transfer pricing assignments;
- c. Cross border work; and
- d. Double taxation treaty work

iii. Graduate Practicing Certificate - This will allow practitioners to compute and file tax returns, provide accounting services to a client, prepare financial statements as well as prepare financial and accounting reports for entities whose turnover does not exceed K5,000,000 per annum, which has less than 100 employees and which investments less land and buildings of not more than K3,125,000. This category of practice certificate will also be restricted from providing services to public interests entities such as entities listed on the securities exchange, entities licensed and supervised by the Bank of Zambia, Pensions and Insurance Authority and Securities and Exchange Commission.

These members will also be prohibited from working on complex assignments such as among other things:

- a. Insolvency practice;
- b. Transfer pricing assignments;
- c. Cross border work, and
- d. Double taxation treaty work
- iv. Full Non-Audit Practicing Certificate this category will cater for Fellows and Associates who meet the current requirements and will allow holders to offer all non-audit professional services without restriction.
- v. A Fellow or Associate who does not qualify for the Full Non-Audit Practicing Certificate but qualifies for the Graduate Practicing Certificate, or the Licentiate Practicing Certificate or the Technician Practicing Certificate will be authorized to apply for such a practicing certificate.

4.2 Competence Practice Examinations requirement

For Full Non-Audit Practice Certificates the existing Competence Practice Examination requirements as stipulated in the Accountants Act 2008 will be maintained.

For the other categories of Non-Audit practice certificates namely Technician Non-Audit practicing certificate, Licentiate Non-Audit practicing certificate and Graduate Non-Audit practicing certificate Competence Practice Exams will be introduced to ensure that applicants can demonstrate that they have the appropriate experience before they are granted practicing certificates.

4.3 Years of experience to practice

For the new categories of Non-Audit practice certificates namely Technician Non-Audit practicing certificate, Licentiate Non-Audit practicing certificate and Graduate Non-Audit practicing certificate there will be a requirement to have a minimum of 2 years post qualifying relevant work experience i.e. after the education requirement has been met.

The proposed 2 years post qualifying work experience is seen as sufficient for the members to be able to carry out the limited work under their certificates. It should be noted that even for Audit practicing certificates the post qualifying experience was amended by the Annual General Meeting of 2011 to 4 years post qualifying experience which should be implemented once the new Accountants Bill is passed.

4.4 Practitioners signing off work

Practitioners will be required to sign off all the work that they perform so that in the event it is discovered that the work performed does not meet the required standards, they can be held liable.

4.5 Continuity Agreements

Holders of the new categories of practicing certificates will be required to sign continuity agreements with other practitioners if they will be operating as sole practitioners as is the case currently with the existing categories of practitioners.

4.6 Agreements with members with holders of Audit or Full Non-Audit Practice certificate

Holders of Technician Non-Audit Practicing Certificate, Licentiate Non-Audit Practicing Certificate and Graduate Non-Audit Practicing Certificate will be required to sign an agreement with a member with an Audit or Full Non Audit Practice Certificate to be able to refer clients to the member with the Audit or Full Non-Audit Practice Certificate in the event that a client requests for services which such a member is not allowed to offer. Those with the Audit or Full Non-Audit Practice Certificate will also be able to refer work that they cannot perform which falls in the category of Technician Non-Audit Practicing Certificate, Licentiate Non-Audit Practicing Certificate, and Graduate Non-Audit Practicing Certificate to them. It is expected that this relationship will also help build the quality of work among the Technician Non-Audit Practicing Certificate as Audit or Full Non-Audit Practice Certificate holders with whom they enter into a relationship will only enter into such a relationship when they are happy with the quality of work performed holders of Technician Non-Audit Practicing Certificates, Licentiate Non-Audit Practicing Certificates and Graduate Non-Audit Practicing Certificates.


4.7 Fees to be paid

Graduates, Licentiates and Technicians who qualify to hold the limited practicing certificates will be required to pay practitioners license fees. The fees will be set at K7,095 per practitioner. Fees paid by Non-Audit practitioners are lower than those paid by audit practitioners. Similarly, the fees for Graduates, Licentiates and Technicians will be lower than those paid by Full Non-Audit practitioners.


5.0 CONSULTATIONS WITH MEMBERS

Two consultative forums on whether Graduates, Licentiates and Technician membership categories should be allowed to provide limited practice where held in Lusaka on 26th November 2019 with 50 members attending and 8th January 2020 with 22 members attending while a further two consultative forums where held in Kitwe on 29th November 2019 with 24 members attending and 16th January 2020 with 24 members attending. Furthermore, a survey was run and a total of 1,024 members responded to the survey.

Only Fellows and Associates are allowed to vote at the annual general meeting or other general meetings and therefore are the only ones eligible to vote on this matter. To get a sense of the views of these members on the matter their support or the lack thereof in during the survey or consultative fora were reviewed. A total of 353 Fellows or Associates participated in the survey or consultative fora while 791 non-voting members participated in the survey or consultative fora.



Out of the total of 353 Fellows and Associates who participated in the consultations, 260 members were in support of the initiative while 93 members where against the initiative as indicated below:



The main theme coming out of the consultations was how ZICA would ensure that the quality of the services being provided would meet the required standard. There are a number of measures that will be put in place to ensure that those who are allowed to provide these services are competent to perform the work. These measures include:

- i. Ensuring that those applying for the practice certificates have relevant experience;
- ii. Designing Competence Practice Examinations for those wishing to practice to ensure that they can demonstrate that they have the appropriate experience before they are granted practicing certificates;
- iii. Carrying out monitoring reviews of those who are granted practicing certificates to ensure that the work they are performing is of the right quality;
- iv. Ensuring that practitioners sign off the work that they perform so that in the event it is discovered that the work performed does not meet the required standards, they can be held liable.

6.0 ROADMAP

6.1 Amendment to Constitution and Accountants Act

The ZICA Constitution needs to be amended by a two thirds majority to allow these new categories of members to provide non audit practice services. The Constitution only allows Fellows and Associates to offer non-audit practice. Section 11 of the constitution states "Upon a written application to the Institute by a Chartered Accountant for a Non-audit Practicing Certificate and on payment of a prescribed fee, the Council may issue a non-audit practicing certificate in accordance with requirements set out in Section 19 of the Act." Chartered Accountant is defined in the Accountants Act of 2008 as follows: "Chartered Accountant means a person holding an associate or fellowship grade of membership of the Institute". A decision to either make the amendment or not needs to be made in the Annual General Meeting.

Section 19 of the Accountants Act of 2008, states "A chartered accountant shall apply for a practicing certificate or a non-audit practicing certificate in the prescribed manner and form upon payment of the prescribed fee". If other membership categories are to be allowed to practice, the Act must be amended to allow for this inclusion. These changes will be included in the Accountants Bill that is due for submission to Ministry of Justice and subsequently to Parliament.

6.2 Developing a framework for regulating new categories of practitioners

Should the meeting resolve that other membership categories be allowed to practice as indicated above, there will be need to develop a framework for regulating the new practitioners before they are allowed to engage in practice. This framework will need to include among other things reviews to ensure that they are adhering to the requirement to provide restricted/limited services as well as performing reviews of the work that they perform. This process should conclude in 2021 and members in the target categories will be alerted by the Institute when it will be possible to begin applying for the practice certificates.

6.3 Engaging staff to carry out reviews

Should the meeting resolve to allow other membership categories to practice, ZICA will need to engage additional staff to be able to carry out the reviews of the new practitioners. This can only be done in 2021 as there will be need to budget for the new staff.

6.4 First Competence Practice Exams

The first competence practice exams will held after the framework for regulating these new categories of practitioners has been developed and staff have been engaged to carry out the reviews. It is estimated that the first competence practice exams will be held in June 2021.

7.0 RESOLUTION

It is proposed that the meeting adopts the recommendation to introduce other categories of practitioners and make a resolution to amend the constitution and replace section 11 of the constitution with the following "Upon a written application to the Institute by an eligible member for a Non-audit Practicing Certificate and on payment of a prescribed fee, the Council may issue a non-audit practicing certificate in accordance with requirements set out in Section 19 of the Act."

1.0 INTRODUCTION

Zambia Institute of Chartered Accountants is a self-regulated membership body for the accountancy profession in Zambia established under the Accountants Act of 1982 and as amended under the Accountants Act of 2008 whose primary mandate is to promote the accountancy profession, through the regulation of accountancy practice and education in Zambia. Its legal framework is further reflected in the Institute's Constitution.

This Paper has been developed in order to provide the necessary perspectives to the proposed review and revision of the ZICA Constitution, which shall replace the ZICA Constitution of 2010 which has been found to have lacunas and is outdated.

2.0 BACKGROUND

Section 6(1) of the Accountants Act and Article 34 of the ZICA Constitution provides for the way and mode of amending the Constitution at the duly convened Annual General Meeting (AGM) through a 2/3 (two-thirds) majority as highlighted here below:

Section 6(1)

- (1) The Institute shall, by a vote of at least two-thirds of the chartered accountants voting at a general meeting of the Institute, adopt a constitution of the Institute and may, in like manner, amend e it.
- (2) The constitution referred to under subsection (1) shall, subject to the other provisions of this Act, regulate the conduct of the affairs of the Institute.

Article 34 of the Constitution

- (1) The Institute shall by a vote of at least two-thirds of the Members voting by secret ballot at a General Meeting of the Institute, adopt this Constitution and shall in like manner amend it.
- (2) The text of any amendments to this Constitution proposed to be moved at the General Meeting, including a summary of any arguments for or against such amendment, which the mover thereof or the Council may wish to circulate, shall be sent with the notice of such General Meeting.

3.0 THE CASE FOR AMENDMENT

The ZICA Council & Management have noted some key defects in the ZICA Constitution including the ZICA Electoral Rules of 2010 which need to be remedied through a holistic ZICA Constitution review process approved by the Annual General Meeting. As a result, the inclusion of an agenda item on the 2020 AGM agenda related to the holistic review of the ZICA Constitution was approved by Council at its meeting of Thursday, 28th May 2020. Among the current defects of the ZICA Constitution and Electoral Rules noted by Council & Management are the following:

- 1. The lack of provisions for virtual holding of the key member meetings of the Institute such as the Annual General Meeting and Special General Meetings including voting virtually;
- 2. Lack of provisions on legal persona of the Institute;
- 3. Lack of gender mainstreaming of Council;
- 4. Lack of provisions which provide for ZICA Chapters;
- 5. Lack of provisions which provide for honorary membership categories;
- 6. Ambiguity and misdirection in some sections by the use of the term "practice" when making

- reference to a chartered accountant who is employed under a contract of service;
- 7. Failure to separate Council from the duty of appointing the Electoral Committee, a process in which Council has a perceived conflicts of interest; and
- 8. Lack of the eligibility criteria for the Electoral Committee.

Further, on the 26th May, 2020, the Institute received a motion to have the constitution amended which was submitted by 23 members consisting of 15 fellows, 7 associates and one licentiate member all in good standing with the Institute except for one. The group cited various reasons for suggesting the amendment of Constitution largely premised on the need to have an all-inclusive, unambiguous and equitable Constitution which could stand the test of time. The summary of the proposed amendments relates to the need to have provisions for reinstatement of members who were once expelled, prescription of the rules relating to members obtaining practicing certificates, removal of a sitting President or Vice President or Council member among others.

The Institute reviewed the submissions in detail and was of the view that the Movers (motion movers as referred to in the ZICA Constitution) had raised legitimate matters and had followed due process in relation to their submission.

Recent challenges such as the need to hold a virtual Annual General Meeting which is not provided for in the Constitution or the Accountants Act demonstrate the need for the Constitution to be reviewed. In addition, Council is cognizant of the fact that the accountancy profession the world over has evolved and matured in many respects which calls for a review of the Institute's Constitution so that it aids growth and embraces emerging approaches to the regulation and management of the accountancy sector. Therefore, in its quest to remain relevant and up to date, the Council fully backs the initiative to propose the review and amendment of the ZICA Constitution.

In addition, the Institute is embarking on some reforms among which is the proposed introduction of the additional practice licences, subject to appropriate support of the members at the 2020 AGM. In the event of the motion to introduce additional practice licences, the ZICA Constitution will need to be amended to accommodate this. The 2020 AGM Agenda includes a matter on the introduction of the additional practice licences.

Lastly, the Zambian Cabinet having approved the 2019 Accountants Bill for enactment into law requires the Constitution to be reviewed and aligned to the Accountants Act once amended which is expected to be done either in the second half of 2020 or in early 2021.

COUNCIL THEREFORE RESOLVES THAT THE ZICA CONSTITUTION REVIEW BE INCLUDED AS AN AGENDA ITEM FOR THE 2020 ANNUAL GENERAL MEETING.

4.0 CONSTITUTION AMENDMENT APPROACH TO BE TAKEN

In amending the Constitution, the approach to be taken will be as follows:

Approach A

A. The amendment of the ZICA Constitution can only be effected at the duly convened Annual General Meeting (AGM) or General Meeting (GM) through a 2/3 (two-thirds) majority as provided by the Accountants Act under section 6(1) and Article 34 of the Constitution as highlighted here below:

Section 6(1)

- (1) The Institute shall, by a vote of at least two-thirds of the chartered accountants voting at a general meeting of the Institute, adopt a constitution of the Institute and may, in like manner, amend e it.
- (2) The constitution referred to under subsection (1) shall, subject to the other provisions of this Act, regulate the conduct of the affairs of the Institute.

Article 34 of the Constitution

- (1) The Institute shall by a vote of at least two-thirds of the Members voting by secret ballot at a General Meeting of the Institute, adopt this Constitution and shall in like manner amend it.
- (2) The text of any amendments to this Constitution proposed to be moved at the General Meeting, including a summary of any arguments for or against such amendment, which the mover thereof or the Council may wish to circulate, shall be sent with the notice of such General Meeting.
- B. The quorum for the AGM to start its proceedings is 10% of the fully paid up members who are eligible to attend and vote at the AGM, which is duly convened.
- C. The motion to propose the overall review of the Constitution with clear justifications for such a review and highlighting proposed amendments to the Constitution should be compiled and submitted to secretariat for Council's consideration. This paper satisfies this condition.
- D. The agenda for the AGM is circulated 21 days before the AGM. The proposed amendments should be submitted to the Institute in good time for circulation to the members. This condition is duly fulfilled.
- E. For the constitution amendment motion to be successfully passed at the General Meeting of the Institute (if this meeting does not concede with the Annual General Meeting), at least a two-thirds majority of chartered accountants who are duly paid up members of the Institute must support the motion.

5.0 RECOMMENDATIONS

The Council hereby recommends the following roadmap for the ZICA Constitution Review process:

- a) Propose the ZICA Constitution Review as an agenda item during the 2020 AGM based on the justification given in this paper. Council is satisfied that the proposal from the 23 members motion has merit and therefore includes proposals from the members' motion as part of the justification for the review of ZICA Constitution. The inclusion of an agenda item on the 2020 AGM agenda related to the holistic review of the ZICA Constitution was approved by Council at its meeting of Thursday, 28th May 2020.
- b) Setting-up a Constitution Review Commission (CRC) once the agenda item is adopted at the 2020 AGM. Once CRC is approved, the Institute will appoint a Committee that will take charge of the constitution review process. The Committee will comprise the following:
 - (i) Both senior members and junior members;
 - (ii) Both male and female members for gender balance;
 - (iii) Representatives from all the three sectors of the profession; Public sector, Public Practice

and Business/Industry. Members from academia should also be represented; and

- (iv) Representatives from various regions and/or ZICA chapters.
- (v) Secretariat

c) Mandate

The CRC will have defined Terms of Reference (ToRs) among which will be to have stakeholder engagements with the general membership to get their views on the constitution. Further, the CRC should have a timeframe to deliver the mandate.

d) Submission of the views

The CRC will compile all the submissions into a report and then generate the draft revised Constitution. The draft revised Constitution will be subjected to a vote at the next AGM for adoption by members.
