IT IS WITHOUT DOUBT THAT THE IMPLEMENTATION OF IPSAS WILL GREATLY INCREASE TRANSPARENCY, GREATER FINANCIAL PERFORMANCE AND ACCOUNTABILITY IN THE PUBLIC SECTOR AND WILL ENHANCE INFORMED DECISION MAKING WITH RESPECT TO RESOURCE UTILIZATION, IMPROVED FINANCIAL INFORMATION TO SUPPORT GOVERNANCE AND MANAGEMENT OF ASSETS.

## LADIES AND GENTLEMEN,

I WISH TO TAKE THIS OPPORTUNITY TO COMMEND THE MINISTRY OF FINANCE THROUGH THE ACCOUNTANT GENERALS OFFICE FOR THE SUPPORT AND COMMITMENT THE MINISTRY HAS SHOWN TO IMPROVE THE PUBLIC SECTOR FINANCIAL MANAGEMENT AND THE SUPPORT GIVEN THUS FAR TO THE IMPLEMENTATION OF THE IPSAS PROJECT.

IT IS THE DESIRE OF THE ZICA TO SEE MORE INVOLVEMENT OF SENIOR POLITICAL LEADERSHIP IN THIS PROJECT FOR ITS SUCCESSFUL IMPLEMENTATION. THE INSTITUTES OBSERVATION ON IPSAS IMPLEMENTATION HAS SHOWN THAT THAT HAVE SUCCESSFULLY COUNTRIES IMPLEMENTED IPSAS WERE BACKED BY STRONG POLITICAL WILL AND WIDER STAKEHOLDER ENGAGEMENT. WITH ITS EMPHASIS ONTRANSPARENCY AND ACCOUNTABILITY. THERE SENSITIVE ISSUES WILL BE THAT THE IMPLEMENTATION OF ACCRUAL ACCOUNTING WILL IMPACT ON HENCE THE CALL FOR POLITICAL SUPPORT.

IPSAS IMPLEMENTATION WILL ALSO ENTAIL CONSOLIDATION OF ALL GOVERNMENT ASSETS AND LIABILITIES INCLUDING MILITARY INSTALLATIONS AND OTHER SENSITIVE INSTALLATIONS. IT WILL ALSO REQUIRE HARMONIZATION AND REVIEW OF EXISTING LEGISLATIONS TO ENSURE THAT THERE IS A LEGAL BASIS FOR PREPARING ACCRUAL ACCOUNTS AND FOR REQUIRING THEM TO BE AUDITED BY THE AUDITOR GENERAL.

THEREFORE, ENSURING THERE IS POLITICAL BUY-IN ACROSS THE BOARD AT THE EARLY STAGES OF THE PROJECT IS VERY CRITICAL AND IMPORTANT. WE THEREFORE URGE GOVERNMENT TO SUPPORT THIS PROJECT TO ITS SUCCESSFUL IMPLEMENTATION.

THIS TRAINING HAS BEEN SPECIALLY DESIGNED TO EQUIP PARTICIPANTS WITH THE REQUIRED KNOWLEDGE TO AID THE TRANSITION AND APPLICATION OF ACCRUAL BASIS INTERNATIONAL PUBLIC SECTOR ACCOUNTING STANDARDS IMPLEMENTATION. IN ADDITION, THE TRAINING IS

AIMED AT PROMOTING EFFECTIVE UTILISATION OF RESOURCES, IMPROVED FINANCIAL INFORMATION TO SUPPORT GOOD GOVERNANCE AND DECISION-MAKING.

I WISH TO BRING TO YOUR ATTENTION THAT THE INSTITUTE ISSUED AN ACCOUNTING PRONOUNCEMENT TO GIVE GUIDANCE ON THE APPLICABILITY OF ACCRUAL BASIS INTERNATIONAL PUBLIC SECTOR ACCOUNTING STANDARDS (IPSAS) IN ZAMBIA IN 2018.

THIS ENTAILS THAT EFFECTIVE 1<sup>ST</sup> JANUARY, 2024, ALL GOVERNMENT MINISTRIES, PROVINCES AND SPENDING AGENCIES WILL BE REQUIRED TO PREPARE FINANCIAL STATEMENTS UNDER THE ACCRUALS IPSAS FRAMEWORK, THOUGH EARLY ADOPTION IS ENCOURAGED. THE COVERAGE INCLUDES CENTRAL GOVERNMENT, GRANT ASSISTED ENTITIES, LOCAL AUTHORITIES AND RELATED GOVERNMENT ENTITIES SUCH AS AGENCIES, BOARDS, COMMISSIONS AND NOT FOR PROFIT ORGANISATIONS. THE INSTITUTE IS

RESOLVED TO PROVIDE ALL THE SUPPORT NEEDED TO OUR STAKEHOLDERS, INCLUDING HOLDING OF WORKSHOPS TO ENSURE IMPLEMENTATION OF IPSAS IS SUCCESSFULLY ACHIEVED.
