STATEMENT ISSUED BY THE ZICA CHIEF EXECUTIVE OFFICER, MR. ANTHONY BWEMBYA ON THE RELEASE OF THE MARCH 2023 ZICA EXAMINATIONS RESULTS

### Good afternoon ladies and gentlemen,

I wish to take this opportunity to welcome you all to the Zambia Institute of Chartered Accountants (ZICA) media briefing on the release of the March 2023 examination results for ZICA programmes. In line with the Accountants Act of 2008, our mandate is to educate and train accountancy professionals required by various sectors of our economy and to contribute positively to our nation's socio-economic development by providing accountants that are market ready to play the crucial role of leading businesses in both the private and public sectors.

On behalf of the ZICA Council and Management, the Institute wishes to thank Management and the lecturers of the approved Universities and Colleges, for the job well done in contributing to the critical processes related to the successfully held March 2023 ZICA examinations. The Institute looks forward to the continued beneficial partnership with the approved Tuition providers and examination centres in the development of work-ready Accountants and business leaders.

I am pleased to announce the March examination results for the Chartered Accountant Zambia (CA Zambia) and the Diploma in Accountancy qualifications. This is the fifth week since the examinations were held and I therefore, extend my commendation to all members of staff at the Institute and our strategic partners in the examination process for the hard work resulting in the release of these results.

As the March 2023 examination results get released, we will reflect on developments related to the following key matters:

#### 1.0 EXAMINATION ENTRIES

I wish to start with highlighting details about entries for the March 2023 examinations.

A total of 1,965 entries were recorded for the March 2023 examinations compared to 4,727 entries recorded in December 2022.

Of the 1,965 entries for the March 2023 examinations, 281 entries were absent from the examinations representing an absenteeism rate of 14.2% compared to 12.6% in December 2022. Students are urged to study and attempt the examinations they pay for in order to avoid wastage of their financial resources.

Of the 1,684 entries present in the examination, 1,072 entries were male candidates, representing 63.7% of the entries compared to 64.3% in December 2022 while 612 entries were female candidates representing 36.3% of the entries compared to 35.7% in December 2022. There was a slight decline in terms of percentage in the number of male candidates in the March 2023 session, while a slight increase was recorded for their female counterparts.

### 2.0 PERFORMANCE

I will now highlight the performance of the candidates that sat for the March 2023 Examinations.

### **Overall Pass Rates**

During the March 2023 Examination session compared to the December 2022 session, it was observed that the overall pass rates for both levels of the Diploma in Accountancy qualification recorded a rise while all those of the CA Zambia qualification recorded a decline. CA Certificate in Accountancy qualification pass rate was the highest at 65.8% while the lowest past rate was recorded in the CA Advisory Professional level of CA Zambia at 30.8%.

Summary of the pass rates in comparison to December 2022 was as shown in the table below:

# Pass Rates by Gender

During the March 2023 Examination Session, it was observed that male candidates have continued to out-perform their female counterparts in all qualifications. The pass rates by gender were as follows:

### Pass Rates by Mode of Study

During the March 2023 examination session, it was observed that the full time students were best performers in both levels of the Diploma in Accountancy qualification as well as the CA Advisory Professional in Accountancy while they were joint best performers with part time students at the CA Certificate in Accountancy level. Self study students were best performers in CA Application Advanced Diploma in Accountancy level.

The comparative pass rates by Study modes are shown below:

## Pass Rates by Number of Attempts

During the March 2023 sitting, it was observed that the pass rates for candidates passing on first attempt were highest at all levels of all qualifications examined.

# 4.1 Highest Scores per Programme

# • CA Zambia qualification

The highest score on this programme was 88% obtained in CA1.4-Commercial and Corporate Law, and CA1.6-Business Communication at the CA Certificate in Accountancy.

### • Diploma in Accountancy

The programme had the highest score of 90% obtained in DA2 – Quantitative Analysis at level 1.
