STATEMENT ISSUED BY THE ZICA CHIEF EXECUTIVE OFFICER, MR. ANTHONY BWEMBYA ON THE RELEASE OF THE JUNE 2023 ZICA EXAMINATIONS RESULTS

Good afternoon ladies and gentlemen,

I wish to take this opportunity to announce the release of the June 2023 examination results for ZICA programmes. In line with the Accountants Act of 2008, our mandate is to educate and train accountancy professionals required by various sectors of our economy and to contribute positively to our nation's socio-economic development by providing accountants that are market ready to play the crucial role of leading businesses in both the private and public sectors.

On behalf of the ZICA Council and Management, the Institute wishes to thank Management and the lecturers of the approved Universities and Colleges, for the job well done in contributing to the critical processes related to the successfully held June 2023 ZICA examinations. The Institute looks forward to the continued beneficial partnership with the approved Tuition providers and examination centres in the development of work-ready Accountants and business leaders.

I am pleased to announce the June examination results for the four ZICA qualifications. This is the fifth week since the examinations were held and I therefore, extended commendation all members of staff at the Institute and our strategic partners in the examination process for the hard work resulting in the release of these results.

As the June 2023 examination results get released, we will reflect on developments related to the following key matters:

1.0 EXAMINATION ENTRIES

I wish to start with highlighting details about entries for the June 2023 examinations.

A total of 3,946 entries were recorded for the June 2023 examinations compared to 1,965 entries recorded in March 2023.

Of the 3,946 entries for the June 2023 examinations, 377 entries were absent from the examinations representing an absenteeism rate of 9.6% compared to 14.2% in March 2023. Students are urged to study and attempt the examinations they pay for in order to avoid wastage of their financial resources.

Of the 3569 entries present in the examination, 2,110 entries were male candidates, representing 59.1% of the entries compared to 63.7% in March 2023 while 1,459 entries were female candidates representing 40.9% of the entries compared to 36.3% in March 2023. There was a decline in terms of percentage in the number of male candidates in the June 2023 session, while an increase was recorded for their female counterparts.

2.0 PERFORMANCE

I will now highlight the performance of the candidates that sat for the June 2023 Examinations.

Overall Pass Rates

During the June 2023 examination session compared to the previous session (March 2023 session for the qualifications with quarterly examinations and December 2022 for the qualifications with bi-annual exam sessions), it was observed that the overall pass rates for all levels of ZICA qualifications recorded a rise. The Diploma in Public Sector Financial Management qualification's overall pass rate at 100% was the highest while the lowest past rate was recorded in the CA Application Advanced Diploma in Accountancy level of CA Zambia at 35.4%.

Summary of the pass rates in comparison to March 2023 and December 2022 was as shown in the table below:

Pass Rates by Gender

During the June 2023 examination session, it was observed that male candidates have continued to out-perform their female counterparts in all qualifications except the Certificate in Taxation. The pass rates by gender were as follows:

Pass Rates by Mode of Study

During the June 2023 examination session, it was observed that the full time students were best performers in both levels of the Diploma in Accountancy and CA Application Advanced Diploma in Accountancy and CA Advisory Professional in Accountancy of the CA Zambia qualification. The part time students led in performance at the Certificate in Accountancy level of CA Zambia while the self study students led in performance at both levels of the Taxation qualification and the Diploma in Public Sector Financial Management.

Pass Rates by Number of Attempts

During the June 2023 sitting, it was observed that the pass rates for candidates passing on first attempt were highest at all levels of all qualifications examined with the exception of the Certificate in Taxation where students attempting for the third time performed best.

4.0 HIGHEST SCORES AND OVERALL BEST PERFORMING STUDENTS IN RESPECTIVE PROGRAMMES

Allow me now to highlight the highest scores obtained under each of our programmes to demonstrate how manageable our examinations are with adequate preparation.

4.1 Highest Scores per Programme

• CA Zambia qualification

The highest score on this programme was 90% obtained in CA2.4-Taxation at the CA Application Advanced Diploma in Accountancy.

• Diploma in Accountancy

The programme had the highest score of 90% obtained in DA2 – Quantitative Analysis at level 1 and DA10 – Taxation at level 2.

• Diploma in Public Sector Financial Management

The programme had the highest score of 83% obtained in PFM2 - Legal Aspects of Public Sector Finance and Administration.

• Taxation

The highest score on this programme was 96% obtained in C1-Business Management at the Certificate in Taxation level.
