STATEMENT ISSUED BY THE ZICA CHIEF EXECUTIVE OFFICER, MR. ANTHONY BWEMBYA ON THE RELEASE OF THE SEPTEMBER 2023 ZICA EXAMINATIONS RESULTS

Good afternoon ladies and gentlemen,

I wish to take this opportunity to announce the release of the September 2023 examination results for ZICA programmes. In line with the Accountants Act of 2008, our mandate is to educate and train accountancy professionals required by various sectors of our economy and to contribute positively to our nation's socio-economic development by providing accountants that are market ready to play the crucial role of leading businesses in both the private and public sectors.

On behalf of the ZICA Council and Management, the Institute wishes to thank Management and the lecturers of the approved Universities and Colleges, for the job well done in contributing to the critical processes related to the successfully held September 2023 ZICA examinations. The Institute looks forward to the continued beneficial partnership with the approved Tuition providers and examination centres in the development of work-ready Accountants and business leaders.

I am pleased to announce the September examination results for the two ZICA qualifications. This is the fifth week since the examinations were held and I therefore, extend commendation to all members of staff at the Institute and our strategic partners in the examination process for the hard work resulting in the release of these results.

As the September 2023 examination results get released, we will reflect on developments related to the following key matters:

1.0 EXAMINATION ENTRIES

I wish to start with highlighting details about entries for the September 2023 examinations.

A total of 2,677 entries were recorded for the September 2023 examinations compared to 3,946 entries recorded in June 2023.

Of the 2,677 entries for the September 2023 examinations, 385 entries were absent from the examinations representing an absenteeism rate of 14.5% compared to 9.6% in June2023. The Institutes has noted with concern the rise in absenteeism rate and urges students to plan, prepare through studies and tuition attendance so that they attempt the examinations they pay for and thereby avoid wastage of their financial resources.

Of the 2,292 entries present in the examination, 1,374 entries were male candidates, representing 59.9% of the entries compared to 59.1% in June 2023 while 918 entries were female candidates representing 40.1% of the entries compared to 40.9% in June 2023. There was a slight increase in terms of percentage in the number of male candidates in the September 2023 session, while that of their female counterparts reduced slightly.

2.0 PERFORMANCE

I will now highlight the performance of the candidates that sat for the September 2023 Examinations.

Overall Pass Rates

During the September 2023 examination session compared to the previous session (June 2023), it was observed that only the overall pass rate for CA Application Advanced Diploma in Accountancy level of CA Zambia recorded a rise. The 59% overall pass rate recorded at the CA Certificate in Accountancy level was the highest while the lowest past rate was that recorded in the CA Advisory Professional in Accountancy level of CA Zambia at 39.5%.

Summary of the pass rates in comparison to June 2023, March 2023 and December 2022 was as shown in the table below:

Pass Rates by Gender

Where performance by gender is concerned, it was observed that male candidates have continued to out-perform their female counterparts in all qualifications. The pass rates by gender were as follows:

Pass Rates by Mode of Study

The September 2023 examination session was further characterized by best performance of full time students in both levels of the Diploma in Accountancy while the self-study students led in performance at CA Application Advanced Diploma in Accountancy and CA Advisory Professional in Accountancy levels of the CA Zambia qualification. The part time students led in performance at the Certificate in Accountancy level of CA Zambia.

Pass Rates by Number of Attempts

During the September 2023 sitting, it was observed that the pass rates for candidates passing on first attempt were highest at all levels of the CA Zambia qualification while those attempting for third time came in second. The pass rates for candidates attempting for the third time was highest at Level 1 of the Diploma in Accountancy qualification while that of those attempting for the second time was highest at level 2.

The comparative pass rates by number of attempts are shown below:

Graduates of the CA Advisory Professional in Accountancy are proceeding or continuing to undertake their supervised practical training in line with the CA Zambia program requirement. The Institute wishes to extend its invitation to employers that have not yet signed up to consider becoming practical training partners on the CA Zambia program while at the same time call upon organizations that have already signed up to take up students currently requiring placements.

4.0 HIGHEST SCORES AND OVERALL BEST PERFORMING STUDENTS IN RESPECTIVE PROGRAMMES

Allow me now to highlight the highest scores obtained under each of our programmes to demonstrate how manageable our examinations are with adequate preparation.

4.1 Highest Scores per Programme

• CA Zambia qualification

The highest score on this programme was 88% obtained in CA2.6-Strategic Business Analysis at the CA Application Advanced Diploma in Accountancy.

• Diploma in Accountancy

The programme had the highest score of 85% obtained in DA12 – Governance and Company Law at level 2.

4.2 Best Overall Students per ZICA Qualification
