STATEMENT ISSUED BY THE ZICA CHIEF EXECUTIVE OFFICER, MR. ANTHONY BWEMBYA ON THE PUBLICATION OF THE SEPTEMBER 2024 ZICA EXAMINATIONS RESULTS

Ladies and gentlemen,

I wish to take this opportunity to announce the publication of the September 2024 examination results for ZICA programmes. In line with the Accountants Act of 2008, our mandate is to educate and train accountancy professionals required by various sectors of our economy and to contribute positively to our nation's socio-economic development by providing accountants that are market ready to play the crucial role of leading businesses in both the private and public sectors.

On behalf of the ZICA Council and Management, the Institute wishes to thank Management and the lecturers of the approved Universities and Colleges, for the continued collaboration whose effectiveness can be seen from the successful holding of the September 2024 ZICA examinations. The Institute looks forward to the continued beneficial partnership with the approved Tuition providers and examination centres in the development of work-ready Accountants and business leaders in line with the ZICA Vision of being a reputable leader in developing finance and business professionals.

I wish to extend commendation to all members of staff at the Institute and our strategic partners in the examination process for the hard work resulting in the publication of these results.

As the September 2024 examination results get released, we will reflect on developments related to the following key matters:

1.0 EXAMINATION ENTRIES

I wish to begin with a highlight of entries for the September 2024 examinations.

A total of 3,096 entries were recorded for the September 2024 examinations compared to of 4,362 entries recorded in June 2024.

Of the 3,096 entries for the September 2024 examinations, 470 entries were absent from the examinations representing an absenteeism rate of 15.2% compared to 10.8% in June 2024. I take this opportunity to urge students to plan and prepare adequately through studies and tuition attendance so that they attempt the examinations they pay for and thereby be prudent with financial resources just as emphasized in the accountancy profession.

In terms of gender, 1,582 (60.2%) of the 2,626 entries present in the September 2024 examination were male candidates while 1,044 (39.8%) were female. This entails a rise for the male candidates when compared to 56.4% and a decline for female candidates at 43.6% in comparison with the June 2024 sitting.

2.0 PERFORMANCE

A highlight of the performance of the candidates that sat for the September 2024 Examinations was as follows:

Overall Pass Rates

During the September 2024 examination session compared to the previous session, it was observed that only the overall pass rate for the CA Advisory Professional in Accountancy qualification recorded a rise. The CA Certificate in Accountancy qualification's 61.7% overall pass rate was the highest while the lowest past rate was that recorded in level 2 of the Diploma in Accountancy at 29.4%. The Institute delights in students performing well and as such will continue with efforts aimed at performance improvement such as holding of examinations answering techniques meetings for students as well as providing resources on the website. Students are particularly urged to reciprocate the Institute's effort by utilizing the provided opportunities for learning as well as study resources in addition to attending tuition.

Summary of the pass rates in comparison to June 2024 and March 2024 was as shown in the table below:

Pass Rates by Gender

Where performance by gender is concerned, it was observed that male candidates out-performed their female counterparts in all qualifications. The pass rates by gender were as follows:

Pass Rates by Mode of Study

The September 2024 examination session was characterized by best performance of full-time students in both levels of the Diploma in Accountancy and CA Advisory Professional in Accountancy while part-time students led in performance in CA Certificate in Accountancy. Self-

study candidates were best performers in the CA Application Advanced Diploma in Accountancy level. The comparative pass rates by Study modes were as shown below:

Pass Rates by Number of Attempts

During the September 2024 sitting, it was further observed that the pass rates for candidates attempting for the first attempt were highest at all levels of the two examined qualifications.

Thirty-two (32) graduates of the CA Advisory Professional in Accountancy are proceeding or continuing to undertake their supervised practical training in line with the CA Zambia program requirement. The Institute wishes to extend its invitation to employers that have not yet signed up to consider becoming practical training partners on the CA Zambia program while at the same time call upon students eligible for practical training to take utilize the currently available approved practical training employers. I would like to further take this opportunity to encourage female candidates that have completed their coursework at either CA Application or Advisory professional level to commence practical training.

4.0 HIGHEST SCORES AND OVERALL BEST PERFORMING STUDENTS IN RESPECTIVE PROGRAMMES

Allow me now to highlight the highest scores obtained under each of our programmes to demonstrate how manageable our examinations are with adequate preparation.

4.1 Highest Scores per Programme

• CA Zambia qualification

The highest score on this programme was 93% obtained in CA1.2 – Business Statistics and CA2.4 - Taxation at the CA Certificate in Accountancy and CA Application Advanced Diploma in Accountancy Levels respectively.

• Diploma in Accountancy

The programme had the highest score of 100% obtained in Cost Accounting at level 1. Special congratulations to Ms. Wanipa Christine Mwale for obtaining the 100% in the paper. This should be taken by other female candidates as encouragement and also a reminder that accountancy as a profession is not a preserve of a single gender.
