- **To drive membership compliance** by ensuring that only paid-up members are issued with valid annual membership certificates.
- To provide external stakeholders—including employers, regulators, and the general public with a simplified and secure way to verify the membership status of ZICA professionals.

Each E-Certificate will feature a unique QR code that links directly to the Institute's verification portal, allowing stakeholders to confirm the authenticity and validity of the member's certificate in real-time. This innovation reinforces ZICA's commitment to promoting professional integrity, transparency, and accountability within the accountancy profession in Zambia.

We encourage all stakeholders to utilize the verification feature when engaging professionals who claim to be members of the Institute. **The Institute will stop issuing physical certificates on 30th September, 2025**.
