### **STATEMENT ISSUED BY THE ZICA CHIEF EXECUTIVE OFFICER, MR. ANTHONY BWEMBYA ON THE RELEASE OF THE DECEMBER 2025 ZICA EXAMINATIONS RESULTS**

**Ladies and Gentlemen,**

I am pleased to announce the official release of the December 2025 ZICA examination results.

In accordance with the Accountants Act No. 13 of 2008, the Zambia Institute of Chartered Accountants (ZICA) remains committed to its mandate of developing competent and ethical accountancy professionals who are responsive to the evolving needs of the economy. Our overarching objective is to contribute meaningfully to national socio-economic development by producing market-ready accountants capable of driving innovation, accountability, and sustainable growth across both the public and private sectors.

On behalf of the ZICA Council and Management, I wish to express my sincere appreciation to the administrators and lecturers from our approved tuition providers. Your continued collaboration and professionalism were instrumental in ensuring the smooth and successful administration of the December 2025 examinations. This partnership remains central to our mission, and we value your ongoing role in shaping competent, ethical, and work-ready accountants and business leaders, in line with ZICA's vision of being a distinguished institution for finance and business professional development.

I also commend the dedication and diligence of ZICA staff, and our strategic partners involved in the examination process. Your commitment, efficiency, and adherence to high standards have made the timely release of these results possible.

The Institute would also like to caution all students against engaging in any form of misconduct or examination malpractice. ZICA maintains a zero-tolerance policy towards practices that undermine the integrity, credibility, and fairness of its examinations. Candidates are therefore urged to uphold the highest standards of ethics and professionalism, in keeping with the values of the accountancy profession. Any breach of examination regulations will attract appropriate disciplinary action in accordance with the Institute's policies and procedures.

With the December 2025 examination results now published, Management will proceed to review performance outcomes and reflect on the key developments arising from this examination sitting, as we continue to strengthen the quality, relevance, and integrity of our professional qualifications:

- 1. Examination entries;**
- 2. Performance;**
- 3. Graduates;**
- 4. High scores in the respective qualifications; and**
- 5. Registration for March 2026 examinations.**

## 1.0 EXAMINATION ENTRIES

Let me begin by outlining the key statistics from the December 2025 examination session.

A total of 5,383 registrations were recorded for the December 2025 examinations. Of these, 755 candidates did not present themselves for the examinations, resulting in an absenteeism rate of 14%. I take this opportunity to encourage students to plan and prepare adequately through consistent study and regular attendance of tuition classes. Candidates are urged to fully utilize the examination opportunities they invest in, in keeping with the principles of financial discipline and responsibility that underpin the accountancy profession.

In terms of gender representation, 4,628 candidates sat for the December 2025 examinations, of whom 2,576 (55.7%) were male and 2,052 (44.3%) were female.

## 2.0 PERFORMANCE

A highlight of the performance of the candidates that sat for the December 2025 Examinations was as follows:

### ***Overall Pass Rates***

A comparison between the December 2025 examination session and the preceding session indicates that pass rates improved only in the CA Certificate in Accountancy, Diploma in Accountancy Level 2, and the Diploma in Taxation Qualifications. The highest pass rate, at 70%, was recorded in the Certificate in Taxation qualification, while the lowest pass rate of 27.7% was registered in the CA Advisory Professional in Accountancy Level.

Summary of the pass rates in comparison to September 2025 and June 2025 was as shown in the table below:

### ***Pass Rates by Gender***

With respect to performance by gender, the results indicate that male candidates outperformed their female counterparts across all qualifications examined during the session.

The pass rates by gender were as follows:

### ***Pass Rates by Mode of Study***

Regarding performance by mode of study, the December 2025 examination session showed varying outcomes across qualifications. Self-study candidates recorded the strongest performance in the CA Application Advanced Diploma in Accountancy, CA Advisory Professional in Accountancy, Diploma in Accountancy Level 1, and the Postgraduate Diploma in Taxation. Full-time candidates, on the other hand, achieved the highest performance in the Diploma in Accountancy Level 2, Certificate in Taxation, and Diploma in Taxation. Notably, self-study candidates also recorded the strongest performance in the CA Certificate in Accountancy.

The comparative pass rates by Study modes were as shown below:

### ***Pass Rates by Number of Attempts***

During the December 2025 examination sitting, it was observed that candidates attempting the examinations for the first time recorded higher overall pass rates compared to those with multiple attempts. This trend highlights the importance of targeted academic support, continuous learner engagement, and timely interventions for repeat candidates to enhance preparedness, confidence, and performance in subsequent sittings. Candidates who did not perform satisfactorily during the session are encouraged to seek quality tuition and professional support from ZICA's approved tuition providers.

Graduates of the various CA Zambia exit qualifications (180) are either commencing or continuing their supervised practical training in accordance with the revised CA Zambia practical training requirement.

## **4.0 HIGHEST SCORES AND OVERALL BEST PERFORMING STUDENTS IN RESPECTIVE QUALIFICATIONS**

I would now like to highlight the highest scores achieved across our Qualifications during the December 2025 examination session. These outstanding results demonstrate that, with adequate preparation and commitment, ZICA examinations are both manageable and rewarding. The following candidates attained the top marks in their respective qualifications:

### ***4.1 Highest Scores per Qualification***

- ***CA Zambia qualification***

The highest score on this Qualification was 93% obtained in CA1.6 – Business Communication at the CA Certificate in Accountancy Level.

- ***Diploma in Accountancy***

The qualification had the highest score of 94% obtained in DA2 -Quantitative Analysis at level 1.

- ***Certificate in Taxation***

The highest score on this qualification was 86% obtained in C1 – Business Management and C6 – Law for Tax Practitioners.

- ***Diploma in Taxation***

The qualification had the highest score of 81% obtained in D5 – International Taxation.

- ***Post Graduate Diploma in Taxation***

The qualification had the highest score of 89% obtained in PGDT2 - Law of Taxation.
