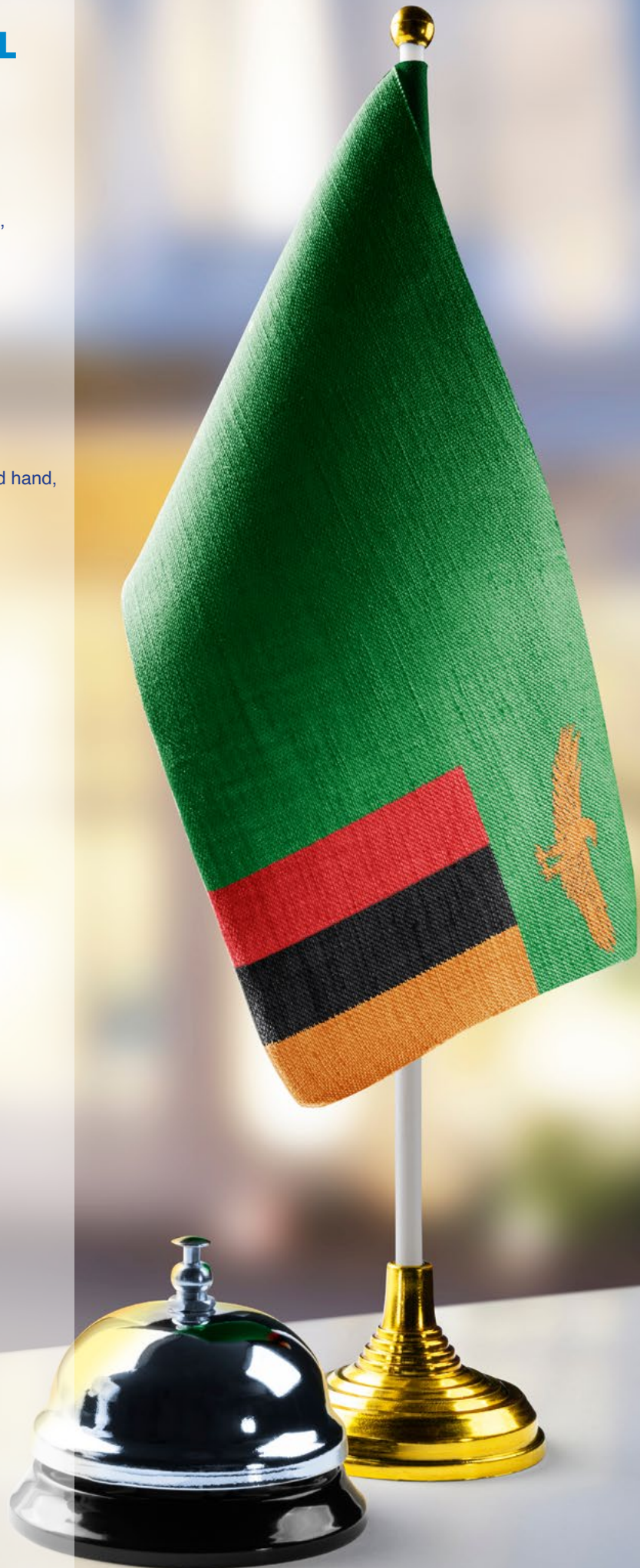

### **1. CALL THE MEETING TO ORDER**

The President called the meeting to order at 09:45 hours upon confirmation that the quorum had been met.

The President called on members to observe a minute of silence in honour of all the ZICA members who had passed on during the year 2024.

### **4. ADOPTION OF THE AGENDA**

The President called on the Secretary to read the notice for the meeting. The Secretary read out the Notice of the Annual General Meeting. ### **5. RECEIVE AND ADOPT THE MINUTES OF THE 39TH AGM HELD AT AVANI, LIVINGSTONE, ON 19TH JULY 2024.**

The minutes of the 39th Annual General Meeting were laid before the members for consideration and adoption.

### **Corrections**

There being no corrections to be made to the minutes of the 39th Annual General Meeting held on 19th July 2024. The minutes were adopted as a correct record of the proceedings thereof after being proposed by Mr. Muneku David Chiyaze membership number: A005739 and seconded by Mr. Mbewe Zephenia membership number: F006544.

## **6. RECEIVE AND ADOPT THE PRESIDENT'S, SECRETARY AND CHIEF EXECUTIVE'S ANNUAL REPORTS FOR 2024**

The President presented the Annual report for the year ended 31st December 2024 which comprised the President and, Secretary and Chief Executive's annual report.

### ***Matters arising from the 2024 Annual Report***

#### ***6.1 Inactive Members***

In response to a member's question regarding the low growth in membership over the past 20 years, the President explained that several initiatives had been undertaken to encourage members to renew their membership. The President indicated that measures had been implemented to improve membership retention, as well as to attract young people to the profession.

These measures included the introduction of incentives such as discounted rates for members on various services and goods, as well as the introduction of flexible membership subscription payment plans, among others. With regard to attracting young people to the profession, the President indicated that strategies under the current Strategic Plan included engagement with students in universities, colleges, and high schools.

In addition, the President noted that, alongside the introduction of enhanced incentive packages for members, the Institute had implemented a robust compliance management system, including the prosecution of individuals suspected of "holding out" contrary to the provisions of the Accountants Act.

#### ***6.2 ZICA Investment Projects***

In response to a member's question as to why the two investment projects had not yet commenced, the President explained that the revenue generated by the Institute had not been sufficient to fund both projects.

The President further indicated that the Institute had been actively engaged in negotiations with potential partners, both within and outside Zambia, with the intention of identifying appropriate modalities for the implementation of the two projects.

The President also called upon members to remain open-minded and to be prepared to reconsider the introduction of a levy should circumstances so require in the future.

#### ***6.3 Adoption of the 2024 Annual Report***

Following presentation of the report, the Annual report for the year ended 31st December 2024 was adopted after being proposed by Mr. Danny Luswili membership number: F000549 and seconded by Mr. Thulani Muchiya member number: F008110.

## **7. RECEIVE AND ADOPT THE AUDITED FINANCIAL STATEMENTS FOR THE YEAR ENDED 31ST DECEMBER 2024**

### ***7.1 Auditor's Report***

The auditors of the Institute, Mark Daniels Chartered Accountants, presented their audit report. The auditors indicated that their report was "unqualified".

### ***7.2 Finance and Administration Committee Report***

The Chairperson of the Finance and Administration Committee gave highlights of the Financial Statements and laid before the Members the Audited Financial Statements of the Institute for the year ended 31 December 2024.

### ***7.3 Adoption***

Following presentation of the audited financial statements, the audited financial statements for the year ended 31st December 2024 were adopted after being proposed by Mr. Kalima Chaleka membership number: F007442 and seconded by Dr. Maj. Humphrey C.L. Mutambo (Rtd) membership number: F000244.

## **8. RECEIVE AND ADOPT RECOMMENDATION FOR APPOINTMENT OF AUDITORS FOR 2025**

Members were informed that the tenure of office for Mark Daniels Chartered Accountants had come to an end and that, Mark Daniels Chartered Accountants had expressed willingness to be reappointed as external auditors for the Institute for the financial year 2025.

It was resolved that Messrs. Mark Daniels Chartered Accountants be reappointed as external auditors for the Institute for the financial year 2025 and that Council be authorized to determine their remuneration. The recommendation was adopted after being proposed by Mr. Cheela Anthony membership number: F005732 and seconded by Mr. Beene Wesley membership number: F000465.

## 9. RECEIVE AND ADOPT THE DISCIPLINARY COMMITTEE ANNUAL REPORT FOR 2024

The Vice Chairperson of the Disciplinary Committee, Dr. Leonard Kalinde, presented the Committee's report to the members.

### Reportable Activities

During the year the Committee received a total of eleven (11) matters. Among these, seven (7) cases were successfully heard and determined. Four (4) cases pertained to examination malpractice, while the remaining three (3) involved misconduct by members.

In response to a member's inquiry about the committee's focus, it was clarified that the committee only addresses complaints submitted to ZICA.

### Adoption

Following the presentation of the Disciplinary Committee Annual report for the year ended 31st December 2024, it was adopted after being proposed by Mr. Muneku David Chiyaze membership number: A005739 and seconded by Mr. Thulani Muchiya membership number: F008110

## 10. RECEIVE AND ADOPT THE STANDARDS AND REGULATORY BOARD ANNUAL REPORT FOR 2024

The Vice Chairperson of the Standards and Regulatory Board, Ms. Natasha Zimba presented the Standards and Regulatory Board report for the year ended 31st December 2024 to the members.

### Reportable Activities

During the year the Board received reports from the Practice Review, Technical, Taxation and Public Sector Committees. The following were the highlights of the main deliberations of the Board:

**Competence Practice Examinations:** the Board approved the results of the Competence Practice Examinations for June and December 2024 examination diets. A total of sixteen (16) candidates attempted the June 2024 examinations. While for December, a total of twenty-five (25) candidates attempted the examinations.

**Practice Review Reports Considered During the Year:** The report of the Practice Review Committee regarding the twenty-four (24) audit monitoring review reports was considered by the Board.

**Complaints from the Public:** The Board considered a total of eight (8) cases during the year 2024. These were cases of professional misconduct, three (3) cases, holding out, one (1) case, two (2) court cases and one (1) discontinued case.

Following the presentation of the Standards and Regulatory Board report for the year ended 31st December 2024 it was adopted after being proposed by Mr. Kelvin Mutale membership number: A008003 and seconded by Mr. Knox Banda membership number: F003252.

## 11. RECEIVE AND ADOPT THE PRACTICE REVIEW COMMITTEE ANNUAL REPORT FOR 2024

A member of the Practice Review Committee, Ms. Rabeca Hichilo presented the Practice Review report for the year ended 31st December 2024 to the members.

### Reportable Activities

During the period under review, the Committee considered twenty-four (24) audit-monitoring visit reports. Two (2) visits were to large firms while twenty-two (22) were to Small and Medium Practitioners.

Following the presentation of the Practice Review Committee report for the year ended 31st December 2024 it was adopted after being proposed by Mr. Mutale Kelvin membership number: A008003 and seconded by Mr. Thulani Muchiya membership number: F008110.

## 12. RECEIVE AND ADOPT THE BENEVOLENT FUND ANNUAL REPORT FOR 2024

The Chairperson of the Benevolent Fund Board of Trustees, Mr. Fred Namakando presented the report for the year ended 31st December 2024 to the members.

### Financial Assistance

During the year the Board supported nine (9) children of late members by paying their school fees. Of these children, two (2) are at secondary school, four (4) at primary school and three (3) at University.

Following the presentation of the Benevolent Fund Board of Trustees report for the year ended 31st December 2024 it was adopted after being proposed by Mr. Beene Wesley membership number: F000465 and seconded by Mr. Jason Kazilimani Jr membership number: F 000336.

The primary objective of the Disciplinary Committee is to hear disciplinary cases, determine and render reasoned judgments in such matters.

## Reportable Activities

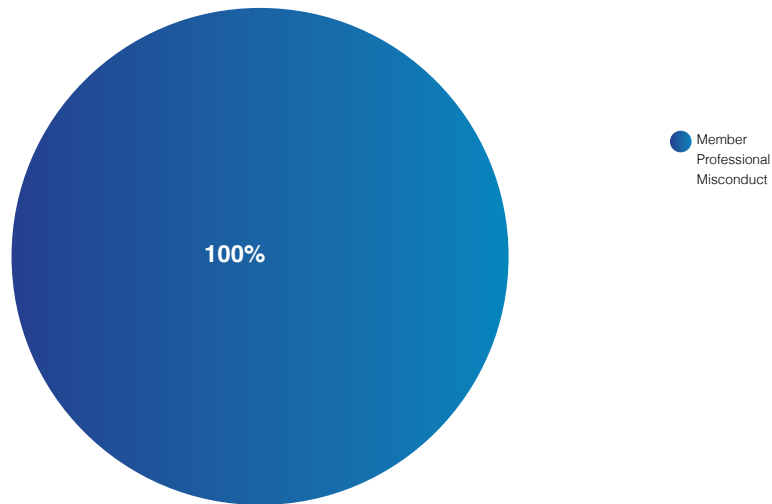
During the year under review, the Committee received a total of eight (8) matters. Among these, seven (7) cases were successfully heard and determined. All cases involved professional misconduct by members. A summary of the concluded cases is provided below.

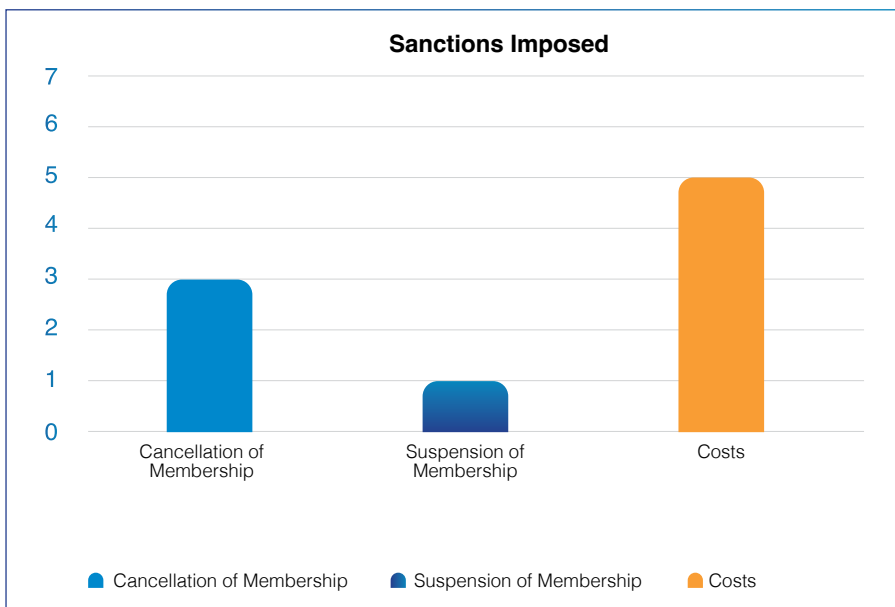

# BENEVOLENT FUND BOARD ANNUAL REPORT FOR 2025

## OBJECTIVES AND OPERATIONS OF THE FUND

The principal objective of the Fund is to raise and maintain funds for the purpose of assisting people in need that are or have been members of the Institute and their spouses or dependents. The Fund also targets to provide critical medical care to members within Zambia on a case by case basis. However, due to constraints in financial resources the assistance is restricted to payment of school fees for children of deceased members.

The fund depends on volunteers for all its administrative work including honorary audit services provided by HLB Zambia.

The major sources of income for the Fund include contributions by members, donations and interest on investments. The income is invested in interest bearing financial instruments. The Fund assists beneficiaries by awarding educational grants to children of deceased members.

### Business transacted during the year

The Benevolent Fund Board met three times during the year under review to review the financial performance of the fund, review strategy and approve financial statements.

### Financial assistance

During the year the Board supported nine (12) children of late members by paying for their school fees. Of these children, two (2) are at secondary school, seven (7) at primary school and three (3) at University.

### Financial highlights

#### Income

Based on the audited financial statements, the Fund recorded a total income of K1,194,663 compared to K693,206 in the previous year. The sources of income were as follows:

As can be seen from the table above, contributions from members improved in the financial year under review. If this trend continues the Committee will be able to support more persons in need.

### Expenditure

The Board spent a total of K213,626 compared to K157,046 in the previous year. Of the total expenditure, K212,426 was spent on requests for school fees for children of late accountants against K155,661 in the previous year.

### Projected Expenditure

In the 2026 financial year, projected expenditure is around K513,000 arising from new cases being recorded.

### Investments and Bank balance

As at 31st December 2025, the bank balance was K1,843,636 (2024, K980,064) and short term investments stood at K680,524.

I must attest that the Fund has given hope to many families of our deceased members who have been at the point of destitution.

On behalf of the Benevolent Fund Board I want to thank all Members and Organizations who made a contribution in any way to the activities of the Fund during the year 2025. The Fund appreciates any assistance members can give to ensure that the Fund continues to provide support to all beneficiaries who are in need. The effectiveness of the Fund depends on the collective contributions of members. As indicated in the financial highlights, membership contributions have improved in the past three years as before 2021 contributions continued to decline whereas requests for financial assistance were on the rise. We are hoping the positive trend continues as it will positively affect the Fund's operations.
